

OCHA has reviewed the attached project proposal from the United Nations Industrial Development Organization and International Labor Organization entitled, "Sustainable Livelihood for Socially Vulnerable Refugees, Internally Displaced and Local Families". The net allocation (excluding Project Support Costs) is \$2,259,000.00. The Project Support Costs for the implementing agencies is \$158,130.00. In addition, a 3% programme support levy is added to the net allocation to cover costs incurred by the United Nations. This amount will be \$67,770.00. Subsequently the total cost of the project will be \$2,484,900.00.

This project requiring \$2,484,900.00 is in line with the guidelines governing the United Nations Trust Fund for Human Security and has been endorsed by the Project Review Committee. I hereby request your approval of this project.
