Further to my Buka 37 on Americans.

1. Vice consul Clarke from Usembura now in Bukavu. Hopes negotiate authorities on release Americans who currently not permitted to leave Kivu. Clarke confirms my information to you as follows. My list of 20 names in Buka 35 is more complete list than known to him but it may include 2 or 3 Canadians. Clarke knows of no other Americans in Kivu province except those at Doctor Beckers mission at Oicha or Oysha on frontier north of Beni of which US embassy Leo has list. Missionary Bothwell of Bukavu went Usumbura a week ago. For embassy's information I repeat that all US missionaries named in my Buka 35 wish to leave Kivu temporarily and are continuing to work only because not allowed leave.

SPECIAL SITREP AS AT 211800Z. A. GROUP OF THIRTY FOUR MEN MEMBERS OF CARTEL GATHERED IN FRONT OF LOC. INVITED THEM TO SCHOOL BLDG AND THEY STARTED SINGING IN WHICH LUMUMBA'S NAME WAS MENTIONED. A SHORT MEETING WAS HELD WITH THEIR COMDT AND COMMISSIONER. COMDT'S NAME NYAMBO BARWAN. FOR INFO OBTAINED. ALFA. THEY WERE TOLD BY AN ANC SGT MAJOR THAT THERE WERE GOING TO BE TROUBLE IN KOSONGO ON 25 MAR. THE INSTRUCTION WAS GIVEN BY A MINISTER IN MAKONG NAMED KATOMBE GEORGE. WHEN ARRIVED KOSONGO THEY WANTED TO ARREST ALL THE PRIESTS BUT WERE STOPPED BY SOMIALO MINISTER OF JUSTICE. SINCE ARRIVAL THEY HAVE NO IN JOB AND NO FOOD TO EAT. BRAVO. CLAIM TO HAVE THE SAME DUTY AS THE ANC. WOULD LIKE TO JOIN THE ANC BUT WERE NOT GIVEN THE CHANCE. SAID TO HAVE RECEIVED SPECIAL INSTRUCTIONS FROM LUMUMBA TO FORM THE ORG TO DEFEND THEIR COUNTRY. TITLE CARTEL WAS GIVEN BY LUMUMBA HIMSELF. SINCE THE FORMATION SIX MONTHS AGO NONE OF THEM HAVE BEEN PAID. THEIR COMDT HAS BEEN TRYING TO CONTACT THEIR HQ BUT WITHOUT MUCH SUCCESS. CHARLIE. AGREED NOT TO DO MORE TROUBLE AND WOULD LIKE VERY MUCH TO GO BACK TO THEIR PLACE CALLED BUYA 325 KILO FROM KOSONGO. GAVE THEM SOME FOOD AND AGREED TO COME BACK TMR FOR FURTHER NEGOTIATION.

Reur BU-218. List supplied covers all American Missionaries in Kivu except those in region Goma to Beni. I am not aware of any American laymen in Kivu. My information obtained from Mr. Vinton, head of Kama Mission. At present there are no American Missionaries in Kama as they are all in Kindu. Local authorities agreed to evacuate Fred and Lois Vinton Junior and baby and Mrs. Lennert Anderson and twin daughters. Mr. and Mrs. Vinton Senior and Miss Betty Frier and Mr. Lennert Anderson will return to Kama as evacuation not authorized by local authorities. They would all prefer to evacuate. Garbled transmission in my 35 should read Mister and Missus Vinton Senior. Only foreigners known at Kakumbu are Missionaries listed in my 35. U.N. patrol has not repeat not visited Shabunda because turned back by ANC on 7 March. I believe Clarke, U.S. Consul Usumbura, has more complete information than I can obtain. Suggest U.S. Embassy Leo contacts him.

Kama.

Mgaxya MBS Vinton and Miss Betty Frier and Lennert Anderson in Vindu but returning to Kama soon to remain at Kama and carry on the work there. To be evacuated. Fred and Lois Vinton and Baby, Mrs Lennert Anderson with Sally and Eline are to leave Kindu soon for USA through the UN.

Shabunda.

Miss Helen Ioffman, Miss Dorothy Rudge and Mr Korkum are at Shabunda, have not been molested and are carrying on. Important to inform Mrs Frier, Benton, Illinois, through US embassy that daughter nurse Frier was not repeat not injured. She is at present in Kindu but will return to Kama. All these missionaries wish to evacuate but local authorities will not permit them. One missionary from Kama was beaten and injured. No other missionaries were injured. Believe some other American missionaries working still in area Rutshuru lubero beni, although most of these evacuate.

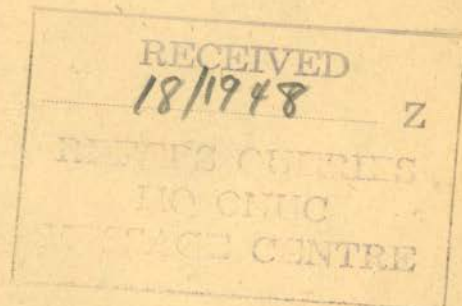

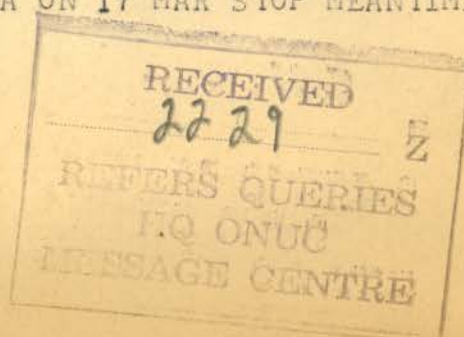
