In response to your memorandum of 10 April 47, received here on 16 April, requesting that a Working Paper be prepared on "The Problem of the Jewish Displaced Persons and Refugees — Statistics, Resettlement Plans, Official Statements, Private Plans, Attitudes, and Public Opinion," I have had certain discussions with the officers of the Department.

A Working Paper will be prepared and submitted before the end of this month.

It should, however, be borne in mind that certain of the figures in this respect are in doubt, and, therefore, though the memorandum will be as accurate as possible, it will be limited by our resources of knowledge. This is particularly the case with respect to "official statements" about which this Department has, naturally, little information, except what appears in newspapers, etc. This section, therefore, will only be included if sufficient information is available. If you have any other source of information on this aspect, it might be desirable, therefore, to have this section separately prepared.

In response to the request in your memorandum of 7 April, I am submitting the following questions for inclusion on the list you will compile:

1. What will be the role of the Inter-Departmental Working Group on Palestine which was authorized by the Secretary-General and is now actively engaged in preparations for the consideration by the Assembly of the Palestine question? Will it be regarded as a nuclear Secretariat group in the Palestine arrangements?
2. What other measures for inter-Departmental co-operation with regard to servicing the Assembly on Palestine should be contemplated, and particularly with respect to the Departments of Security Council Affairs and Trusteeship?
3. On what basis will the Secretaries of possible special committees be selected?
4. Will adequate verbatim records service be ensured?
