(4) United Kingdom Representatives, United Nations Military Staff Committee.

(5) U.S. Representatives, United Nations Military Staff Committee.

(c) The Chairman and the Secretariat of the Military Staff Committee.

(1) The Chairman, United Nations Military Staff Committee.

(2) The Principal Secretary, United Nations Military Staff Committee.

(3) The Secretariat, United Nations Military Staff Committee.

(d) The Secretaries of each Delegation.

(1) The Secretary, Chinese Delegation, United Nations Military Staff Committee.
