FRANCO-BELGIAN CONTACT SEE ELLEO 943 CALLED ON US ON HIS RETURN FROM NDOLA THIS AFTERNOON. HE REPORTS THAT LAST NIGHT IN THE SAVOY HOTEL NDOLA HE OBSERVED

1. CARLOS HUYGHE FORMERLY CHEF DE CABINET OF MINISTER OF DEFENCE YAV. AS YOU RECALL, HUYGHE WAS EXPELLED ABOUT THE 5TH AUGUST AS FALLING UNDER RESOLUTIONS

2. A NUMBER OF WHITE FORMER GENDARMERIE OFFICERS WHOM HE KNEW BY SIGHT HAVING RESIDED IN EVILLE FOR MANY YEARS BUT COULD NOT NAME

3. ABOUT 12 YOUNG MEN, RHODESIANS, ITALIANS AND SOUTH AFRICANS WHO SPOKE OPENLY OF THEIR INTENTION TO TRAVEL TO KOLWEZI BY CHARTERED PLANE TO TAKE SERVICE WITH THE KATANGAN FORCES

IN HIS OPINION HUYGHE AND THE OTHER GENDARMERIE OFFICERS ARE ORGANIZING RECRUITMENT FROM ACROSS THE RHODESIAN BORDER. CRENER AND HERCKENS WHOM I QUESTIONED ABOUT HUYGHE ADMITTED THAT HE HAD RETURNED TO KATANGA AND THEY BELIEVE HIM TO BE IN KIPUSHI. THIS LEAVES LITTLE DOUBT THAT RECRUITMENT AND SUPPLY ARE BEING ORGANIZED ON THE RHODESIAN BORDER. WE FEEL THAT THIS EYEWITNESS REPORT CORROBORATED AS FAR AS HUYGHE IS CONCERNED BY THE BELGIAN CONSUL HERE MAY SAFELY BE TRANSMITTED TO NEWYORK AS A BASIS OF DEMARCHE TO THE BRITISH GOVERNMENT AND THE RHODESIAN AUTHORITIES

AS I WAS ANXIOUS TO SEE WHAT WAS GOING ON I SAW OVER 150 OF THESE WHITE RHODESIAN SOLDIERS GATHERING INTO THIS NEW EMERGENT CAMP, ALL DRESSED IN KATANGAISE GENDARME UNIFORM. AFTER SOMETIME THEY CAME OUT NOW DRESSED IN CIVILIAN CLOTHES GOT INTO PRIVATE CARS AND MADE FOR TOWN. I ASKED ONE OF THE KATANGAISE SOLDIERS TO TELL ME HOW THEY FOUGHT. WHEN HE FOUND OUT THAT I WAS FROM RHODESIA, HE WAS NOT AFRAID OF TELLING ME HOW THE POSITION WAS. HE ADMIRERD THE RHODESIAN GOVERNMENT WHICH SENT IN PLENTY OF THEIR SOLDIERS ARMS AND AMMUNITION. FIRSTLY. ON THE 21 SEPTEMBER COLONEL VAN DEN VALLE CALLED ON HQ SECTOR B AT 1700 HOURS. HE STATED THAT HIS MISSION IN KATANGA WAS TO TAKE CARE OF INTERESTS OF BELGIAN OFFICERS ON BEHALF OF THE BELGIAN GOVERNMENT. THERE WAS NO MEETING ARRANGED WITH COLONEL VAN DEN VALLE. THE MOST URGENT PROBLEM ARISING FROM THE IMPLEMENTATION OF THE
CEASE-FIRE AGREEMENT IS THAT OF EUROPEANS IN GENDARMERIE UNIFORM AND
VISIBLY ARMED EUROPEANS. WE CONSIDER THAT THESE PEOPLE WHO ARE ACTING
ILLEGALLY DO NOT FALL UNDER THE CEASE-FIRE AGREEMENT AND WE SEEK
AUTHORITY TO APPREHEND THEM USING FORCE IF NECESSARY. IF THIS IS NOT
DONE VERY QUICKLY ELISABETHVILLE WILL REVERT TO SOMETHING LIKE ITS
