OVERVIEW

1. NO CHANGE.

RPA

2. SECTOR 2: RILIMA: 130045B MAY: A LOCAL WOMAN REPORTED THAT HER 30 YEAR LD SON HAD BEEN SHOT IN THE HEAD AND KILLED BY THE CONSEILLE RESPONSABLE AND HIS ASSISTANT, SUPPORTED BY UNIFORMED PERSONNEL AND A FEW LOCALS. INVESTIGATIONS ARE ON-GOING.

3. SECTOR 3:

- A. KIBUYE: 13/14 MAY: AT LEAST FOUR .50 CALIBRE HMGS SIGHTED IN KIBUYE AREA, PROBABLY IN PREPARATION FOR THE VISIT BY VICE-PRESIDENT KAGAME AND ENTOURAGE.

- B. (??) THREE RPA SOLDIERS BROKE INTO A MILOB RESIDENCE AND STOLE A TOYOTA 4-RUNNER. THE SOLDIERS FIRED AT THE HOUSE TO PREVENT INTERFERENCE IN THE THEFT. IT APPEARS THAT THE THEFT WAS COMMITTED BY CERTAIN LOW LEVEL CADRE OF RPA, PROBABLY IN COLLUSION WITH OTHERS IN KIGALI. THE PREFECT PERSONALLY VISITED SECTOR 3 HQ TO EXPRESS HIS CONCERN. BY APPEARANCES, THE LOCAL AUTHORITIES AND THE RPA LEADERSHIP ARE GENIUNELY EMBARRASSED AND ARE MAKING EFFORTS AT THE VEHICLE'S RECOVERY.

3. SECTOR 4A:

- A. CYAFURWE (5417): THE COUSEILLEUR OF CYAFURWE HAS FLED HIS HOUSE FOR FEAR OF ARREST BY RPA. CIVPOL AND HUMAN RIGHTS MONITORS ARE INVESTIGATING.

- B. BRIDGE AREA GR 532081: THE RPA COY WHICH HAD BEEN DIGGING IN AT THIS AREA, OSTENSIBLY AS A TRAINING EXERCISE, HAS VACATED THE SITE. COMMENT: CONSIDERING THE DIGGING ACTIVITIES COINCIDED WITH THE ASSESSED REMOVAL OF BODIES FROM KIBEHO CAMP, THIS AREA COULD POSSIBLY HAVE SERVED AS ONE OF MANY DUMPING SITES FOR SOME OF THE DEAD FROM KIBEHO CAMP.

4. SECTOR 5: NDUSU IDP CAMP: RPA TROOPS IN THE AREA ARE REPORTEDLY THREATENING RETURNEES AND DEMANDING MONEY FROM THEM.

SUBJECT : REPORT FOR UNAMIR AND HUMAN RIGHTS AGENCY

1. Sector 1 Milob HQ was approached by a Hutu gentleman in total confidence to convey an application on behalf of Hutus residing in Byumba prefecture to UNAMIR and Human Rights Agencies . The gentleman is not being named for obvious reasons.
2. The application written in French was translated by our Francophone Milobs , however the results are not satisfactory . As this HQ is reluctant to approach any local interpreters , you are requested to have the enclosed original document translated into English ,by using the services of a bilingual Milob and forward copies (in both languages) to HQ UNAMIR and the Human Rights .
3. Please fwd a translated copy of the document to this HQ for carrying out further inquiries and taking necessary follow up actions if any.
4. Please downgrade the letter to Unclassified after detaching the contents .
