Dear Mr. Haunser,

At Mr. Cordier's request, I am writing to explain in more detail the reasons why we would prefer not to allocate so far ahead the symbol number for the final report of the Temporary Commission on Korea.

In the first place, we cannot at present foresee whether, by the time we receive the Commission's report, we shall have received enough Assembly documents to bring up anywhere near the number you suggested in your cable. If not, there is always a possibility of error in that intervening numbers might be overlooked, though that, we hope, would be unlikely. Further, any gaps in the numbering system, as we have experienced in the past, lead to continual enquiries from delegations as to the reasons for the missing numbers.

Secondly, we should assume that the draft report will, in the first place, be given an A/AC.19 number and that it will not be transformed into an Assembly document until it has been received at headquarters, which presumably would not be until well after the elections.

We would therefore suggest that immediately on receipt of the final report we should cable the number to you if that would be of any assistance. Alternatively, if you would be good enough to explain to us by letter for what reasons you require a document number in advance and let us know when the completion of the report is imminent, we should be glad to cable an advance number at that time.

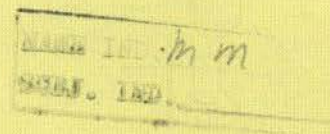

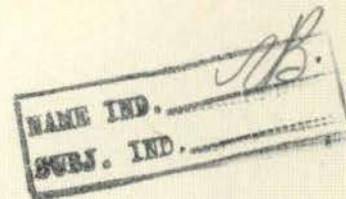

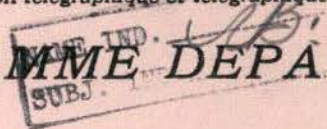

Additional Post for Korean Commission

We have received a letter from the French delegation seriously protesting against the incompetence of the French-English interpreter assigned to the United Nations Temporary Commission on Korea. It has been necessary to send another interpreter to replace him.

As I recall having sent you extracts from a report from Mr. Coke, Administrative Officer to the United Nations Special Committee on the Balkan Question, which also contained complaints about the incompetence of some staff members selected for that mission, it seems to me that this confirms my belief that in the future, selection of personnel for field missions should be more carefully looked into by your Bureau. Sending incompetent staff back to Headquarters and replacing them by more qualified personnel from Headquarters means unnecessary extra expenditures. This should be avoided as much as possible. I wish you would instruct your recruitment staff to examine more carefully the qualifications of the candidates for field mission posts, and consult their former supervisors on the desirability of sending such candidates on a mission.

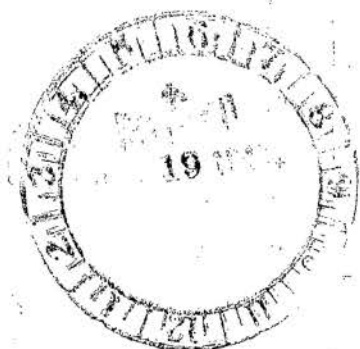

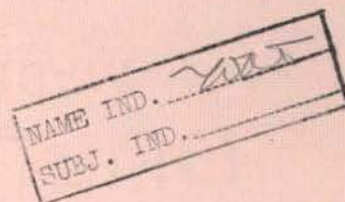
