Subject: Credentials for Representatives to the Economic and Social Council - Authority of Permanent Representatives.

Thank you for your memorandum commenting on the proposed report regarding credentials at the Economic and Social Council.

Your suggestion that we should not include the principal permanent representative in the list of authorities empowered to issue credentials has considerable merit especially in the light of the General Assembly resolution on the status of permanent missions. Nevertheless it has seemed to me necessary to include the permanent representatives because of the discussion which took place at the Committee on Procedure of the Council when that Committee considered the new rule on credentials. You will note that at the fifteenth meeting of the Committee (E/AC.28/SR.15 pages 8 et seq.) it was proposed by the representatives of Belgium and Peru that the new rule expressly provide that credentials shall take the form of a communication from the head of the state or government or from the Minister for Foreign Affairs "or from the permanent representative of that government to the United Nations". In reply to a question put by the representative of Belgium Mr. Schreiber stated: "In principal, communications from permanent representatives were usually accepted". Thereupon Mr. Lebeau stated that "in that case he wished to withdraw his amendment". The representative of the United Kingdom similarly appeared to rely upon the statement by Mr. Schreiber in deciding that further changes in the rule would not be necessary.

Thus the discussion of the problem indicates that the representatives did not include a provision regarding this point because they relied on the Secretariat's position that credentials from principal permanent representatives would be accepted. This conclusion is strengthened by the actual practice in the Council where it appears that many of the delegations rely upon credentials signed by the principal permanent representatives.

It is true that paragraph 4 of Assembly Resolution 257 (III) recommends that the Member States specify whether the permanent representatives are to represent them on one or more organs of the United Nations and therefore the Council should perhaps require that such powers be granted to the permanent representatives before recognising them as authorised to issue credentials. But if the Council chooses to follow a more liberal rule it would appear free to do so regardless of this particular provision in the General Assembly resolution.

Incidentally I mentioned this point to Dr. Saba who was here yesterday and while he was inclined to favour a stricter rule if the question was still an open one, he did agree that since the Council had the power to adopt its own rule regarding credentials, it was not bound to conform to the General Assembly resolution.
