SUBJECT: CIVIL COMPLAINT BY RAFAEL KABONGO THAT ETHIOPIAN OFFICERS HAD CONFISCATED SOME OF HIS PERSONAL PROPERTY.

1. On 9 APR 62, a Congolese man, Rafael KABONGO, reported to this office requesting police assistance. He stated that he had been employed by the UN from MAR 61 to DEC 61. When he first engaged with the UN he was working in LULUBOURG. Later he was transported by UN aircraft to LEOPOLDVILLE where he worked with the Tunisian soldiers, in the medical department. He stated that he had been given permission by a Tunisian officer to sleep in one of the UN villa's. The villa in which he slept was No 149 avenue Angels, LEO II. He stated that he had brought a mattress and a set of springs with him from LULUBOURG.

2. In OCT 61, the Tunisians left LEOPOLDVILLE and KABONGO was transferred to ONUC hospital. In DEC his employment was terminated. The villa's surrounding KABONGO were now occupied by Ethiopian officers. On 14 DEC 61, several thefts occurred in the Ethiopian villa's and several mattresses and springs were stolen. I was successful in returning some of the articles but some mattresses are still missing. At this time the Ethiopian accommodation officer was informed that the villa in which KABONGO was sleeping, was on charge to UN. KABONGO was therefore asked to leave and a guard was supplied for this villa. KABONGO reported the matter to this office in JAN 62 and stated that some of his clothing was still in the villa. Sgt L LEDOUX, Canadian MP, now in CANADA, returned the clothing to KABONGO but since several mattresses and springs had been stolen from this area and they were identical to the one KABONGO said was his, the Ethiopian accommodation officer could not hand over these articles without more proof that they belonged to KABONGO.

3. Up to this date this office has not been able to supply the necessary proof. KABONGO is now residing at 25 LAYONGA street, NOUVELLE CITE.
