2. The above recommendation has the Secretary-General's approval.



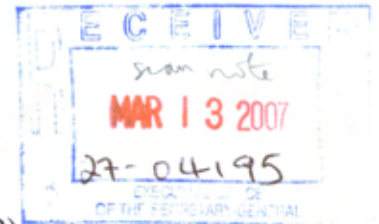

Note to Mr. Nambiar

Director of the United Nations Office in Belgrade (UNOB)

1. Following the departure of Mr. Harston as outgoing Director of UNOB, SRSR Rucker has proposed Mr. Jens Modvig (Denmark), currently the Deputy Head of Mission of the OSCE Pillar of UNMIK, for the position of Director of UNOB at the D2 level.
2. We have reviewed Mr. Modvig's background and believe he is a strong candidate for the position. We have consulted with Special Envoy Ahtisaari, who is of the same view. Mr. Modvig would bring to the position extensive managerial and operational experience in the Balkans. In light of developments in Serbia and the intensity of the Kosovo future status political process, it is important that a Director for UNOB be selected in the shortest possible timeframe.
3. We therefore recommend that the Secretary-General appoint Mr. Modvig as Director of UNOB at D2 level for an initial period of 6 months. Please find attached as background the most recent senior leadership profile for UNMIK.
4. We would be grateful for the Secretary-General's approval of Mr. Modvig's appointment.
