



An invitation to the SG directly from the President does require attention.

Thus, without having any additional info at this point about the specific event or the role of the conference within the framework of the Post 2015 debate in Europe or Eastern Europe, if the SG's schedules permits and in case he will be in Europe at the time, he could consider attending the event. I do not believe a self-standing visit to Czech Republic to attend this conference shall be considered.

SG's participation in this event could be a good opportunity for the SG to emphasize the role of new donors (Czech Republic) in the new development agenda, but also to raise the question of the challenges of P2015 for the MICs. This also would give opportunity to raise the challenges of transition to democracy, among other issues.....

If SG could not go, I believe ASG Mohammed could represent him (to be consulted with her), otherwise the natural choice shall be the USG Alkalaj (ECE Executive Secretary). ECE ES presence could also minimize costs of transportation.
