The Executive Office of the Secretary-General presents its compliments to the Permanent Mission of the Democratic Republic of Timor-Leste to the United Nations and acknowledges its Note Verbale of 4 August 2010, requesting a meeting between the Secretary-General and His Excellency Mr. José Ramos-Horta, President of the Democratic Republic of Timor-Leste, between 20 and 25 September 2010.

The period during the opening of the sixty-fifth session of the General Assembly, the High-level Plenary Meeting on the Millennium Development Goals and the General Debate will be an extremely busy time for all parties. Be assured that the request was brought to the attention of the Secretary-General. The Executive Office of the Secretary-General is still receiving information about numerous meetings and events relating to the session that will require the presence of the Secretary-General. It is therefore not possible to determine how much time will be available for bilateral meetings, until closer to the opening of the General Debate.

In the interim, the Executive Office of the Secretary-General would appreciate if the Permanent Mission of the Democratic Republic of Timor-Leste to the United Nations could inform Mr. Yeocheol Yoon, Chief of the Scheduling Office, should there be any changes in the plans of the President, or any details regarding the topics to be discussed in the requested meeting.
