
Dear Mr. President,

Please accept, Mr. President, the assurances of my highest consideration.



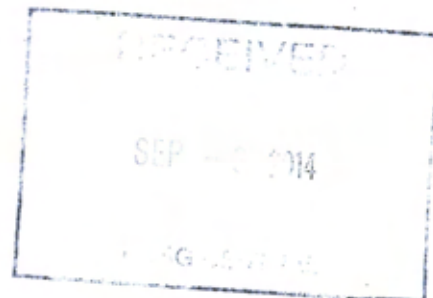

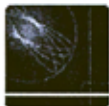
