On the development of the comprehensive mobility framework:

1. To send a memorandum, from the Chair of the MC, urging senior managers to continue to work with OHRM in determining which specialist posts should be given special consideration.

On the status of implementation of the International Public Sector Accounting Standards (IPSAS):

2. Consistent with the position adopted by the Committee on the importance of strategic engagement by senior management with the Board of Auditors (BOA), welcomed the opportunity of the Chef de Cabinet's meeting with the BOA in July as a means of further consolidating this partnership.
3. To ensure that the Organization remains on track for the implementation of IPSAS by 2014 by, inter alia, encouraging the Heads of Departments/Offices, Regional Commissions and Field Missions to intensify the monitoring of IPSAS implementation preparations in their areas, report progress monthly, and lend support as necessary, especially in view of the budgetary constraints during 2012-2013.
4. To note that the Secretary-General's Fifth Progress Report on IPSAS will be finalized by 30 August 2012.
