LOA:

LETTER OF ASSIST

WHEREBY THE UNITED NATIONS REIMBURSES THE TROOP CONTRIBUTING NATION FOR THE USE OF THE COUNTRIES MILITARY OR NATIONAL CARRIER.

THE AIRCRAFT, ALTHOUGH OPERATED BY THE NATIONAL AIRFORCE OR COMMERCIAL CREW, COMES UNDER THE CONTROL OF THE MISSION IT IS SUPPORTING.

ALL RELEVANT LOAD PLANNING, CUSTOMS CHECKS, DANGEROUS GOODS CHECKS, IMMIGRATION & RAMP CONTROL IS COORDINATED BY UNITED NATIONS MOVEMENT CONTROL.

OVERFLIGHT CLEARANCES, LANDING CLEARANCES & FUEL IS ACTIONED BY THE CARRIER.

UN CHARTER:

WHEREBY THE MOVEMENT COORDINATION CENTRE UNITED NATIONS NEW YORK CHARTERS AN AIRCRAFT CAPABLE OF CARRYING OUT THE NEEDS OF THE MISSION.

AGAIN THE MOVEMENT CONTROL ORGANISATION IN THE MISSION AREA IS RESPONSIBLE FOR THE MOVE.

OVERFLIGHT CLEARANCES, LANDING CLEARANCES & FUEL IS ACTIONED BY THE CARRIER.

UNAMIR AIRCRAFT:

CHARTERED BY UNNY IN SUPPORT OF THE MISSION. TASKED FOR AIR SPT BY MOVEMENT CONTROL.

PROHIBITED GOODS
TO BE MOVED BY AIR

1. The following items are not to be moved on Commercial, Charter or UN Aircraft unless cleared and approved by MOVCON.

- a. AMMUNITION AND EXPLOSIVES
- b. FIREARMS
- c. WEAPONRY OF ALL TYPES
- d. BOOK TYPE MATCHES
- e. FLAMMABLE LIQUIDS AND SOLIDS (ie: HEXAMINE TABLETS)
- f. GAS CYLINDERS
- g. NON MEDICINAL DRUGS
- h. CIGARETTE-LIGHTERS CONTAINING UNABSORBED LIQUID
- i. ANIMALS (DEAD OR ALIVE)
- j. EXPENDED AMMUNITION SHELLS
- k. RADIOACTIVE MATERIAL

2. The above are classified as Dangerous Goods for Air Movements. The United Nations is bound by the International Air Transportation Laws and are obligated to adhere to these regulations.

3. Movement Control will advise passengers of any other items which may be considered dangerous.
