3. (a) One team patrolled route RILIMA 2561, GASHORA 2655, SAKE 4354, ZAZA 4759. Bridge at GASHORA 285562 has been washed away in the rain. There is a requirement of an engineer rep to carry out a recce of the site to assess the damage and the nature of effort required to restore communication along road GASHORA-SAKE.  
  
(b) One team patrolled RUSUMO 7448 commune. They investigated the alleged detention of 36 UNAMIR vehicles by RPA at the border post. They found that the vehicles were held up only for customs formalities and not detained. They are likely to leave for KIGALI today.  
  
(c) One team patrolled route RILIMA, GAKO 1953, MAYANGE 1357, KANAZI 0963, RILIMA. The sit is calm.  
  
(d) HQ Sub Sect 2A has shifted to NYAMATA 1060 with immediate effect. GR of Sub Sect HQ is 099631 and of helipad 098629. CU 0A is op from NYAMATA and CU 0B from RILIMA.
4. (a) There are 320 returnees at ASPEK KIBUNGO at present. Commune wise details are as under:-  
(i) RUKIRA 6658 - 112.  
(ii) KAYONZA 5784 - 30.  
(iii) BIRENGA 5959 - 18.  
(iv) RUSUMO 7448 - 70.  
(v) KIGERAMA 6170 - 90.  
  
(b) 269 IDPs have arrived from NDERA transit camp at GASHORA 2655 between 11-17 May. They need plastic sheeting.  
  
(c) 1500 IDPs are at ISAAR KARAMA camp. There is no food available. Water is being supplied twice a week by UNHCR. Almost 50 people have reported diseases ranging from malaria and stomach worms.
