1. ON 21 JUNE CONGOLESE AUTHORITIES ORDERED GROUNDING OF ALL INTEROCEAN PLANES. I TOOK UP MATTER WITH ADOULA WHO, AFTER STUDYING MATTER, INFORMED ME ON 24 JUNE THAT DECIDED TO IN RESPONSE TO MY REPRESENTATION HE HAD/ALLOWED ONUC CHARTERED PLANES TO FLY UNTIL END JUNE WHEN CONTRACT WITH ONUC EXPIRED.
