The V Baku International Humanitarian Forum will be held on 29-30 September 2016 in Baku, Republic of Azerbaijan. The Forum was initiated in 2010 by the President of the Republic of Azerbaijan H.E. Mr. Ilham Aliyev and since then has been convened annually by the Government of the Republic of Azerbaijan and the Heydar Aliyev Foundation. The Forum brings together distinguished personalities, including acting or former heads of state, scientists, heads of international organizations and representatives of civil society and mass media, to exchange views on the issues of mutual interest and concern and, in that context, on further developing international humanitarian cooperation.
