

- 342) Trial of Ulrich Greifelt and 13 others, (Subsequent Proceedings Case No. 8). RKFDs (Reichs Commissariat for the strengthening of Germanism.)
Date & Place of Trial: The trial will be held at Nuremberg.
Indictment only has been received.
Charge: Crimes against humanity and war crimes as defined in Control Council Law No.10, including murders, brutalities, cruelties, tortures, atrocities, deportation, enslavement, plunder of property, persecutions and other inhumane acts. All except one are further charged with membership in a Criminal Organisation.
- 343) Trial of Otto Ohlendorf and 23 others. (Subsequent Proceedings Case No. 9) "Einsatzgruppen": Special task forces (SS., SD., Gestapo, and Police units).
Date & Place of Trial: The trial will be held at Nuremberg.
Charge: Crimes against Humanity and War Crimes... including murder of more than one million persons, tortures, atrocities and other inhumane acts, and also membership in criminal organisations.
- 344) Trial of Alfried Krupp von Bohlen und Halbach, Owner and Directing Head, and 11 others, Officials of the Krupp Firm and Family Enterprise. (Subsequent Proceedings Case No.10)
Date & Place of Trial: The trial will be held at Nuremberg.
Only the Indictment has been received so far.
Charge: Crimes against Peace, War Crimes and Crimes against Humanity, and that they participated in a common plan and conspiracy to commit crimes against peace, all as defined in Control Council Law No.10... including planning, preparing, initiating and waging wars of aggression and invasions of other countries, as a result of which incalculable destruction was wrought throughout the world, millions of people were killed, and many millions more suffered and are still suffering; deportation to slave labour of members of the civilian population of the invaded countries and the enslavement, mistreatment, torture and murder of millions of persons, including German nationals as well as foreign nationals; plunder and spoliation of public and private property in the invaded countries pursuant to deliberate plans and policies intended not only to strengthen Germany in launching its invasions and waging its aggressive wars and to secure the permanent domination by Germany of the continent of Europe, but also to expand the private empire of the defendants; and other grave crimes as set forth in the Indictment.
- 345) Trial of Giannantonio Licata, an Italian national.
Date & Place of Trial: 26 - 28 May 1947 at Leghorn, Italy.
Charge: That he killed a member of the military forces of the United States.
Verdict: Not Guilty.
- 346) Trial of Ernst Mueller, a German national.
Date & Place of Trial: 19th March 1946 at Ludwigsburg.
Charge: Wilfully, deliberately and wrongfully encouraging, aiding, abetting and participating in the killing of a member of the U.S. Army, then an unarmed, surrendered PoW, by shooting him with a gun.
Verdict: Guilty.
Sentence: Death by hanging.

347) Trial of Ludwig Schickert, a German national.

Date & Place of Trial: 3rd January 1947 at Dachau before an Intermediate Military Government Court.

Charge: That he wrongfully committed an assault upon a member of the U.S. Army Air Force who was then an unarmed, surrendered PoW, by hitting him with his fists and by kicking him.

Verdict: Guilty.

Sentence: Imprisonment for 2 years.

348) Trial of Mitsuzo Inagaki, a Japanese national.

J. Date & Place of Trial: 28 July - 1 August 1947 at Yokohama.

Charge: Beating, kicking, abusing, causing the death of American, British and Australian PoWs.

Verdict: Guilty.

Sentence: Imprisonment for 30 years with hard labour.

349) Trial of Hiroshi Azuma and 6 others, Japanese nationals.

J. Date & Place of Trial: 21 - 31 July 1947 at Yokohama.

Charge: Kicking, beating, abusing, gross mistreatment and contributing to the deaths of British and American prisoners of war.

Verdict: All found guilty.

Charge: Beating, mistreating and abusing American and Australian prisoners of war.

Verdict: One accused was withdrawn from the trial and tried separately.

Two found guilty.

351) Trial of Ido Turchi, an Italian national.

Date & Place of Trial: 3 - 5 June 1947 at Leghorn.

Charge: That he did wilfully, deliberately, feloniously, unlawfully and contrary to the law of war, with premeditation, summarily kill a member of the U.S. Military Forces who had then recently been captured and was a PoW, by striking him with a rifle butt and bayonetting him.

Verdict: Guilty.

Sentence: Death by hanging.

352) Trial of Herman Noack and Karl Georg Boess, German nationals.

Date & Place of Trial: 29 July - 5 August 1946 at Dachau, before an General Military Government Court.

Charge: That they wilfully, deliberately and wrongfully encouraged, aided, abetted and participated in the killing of two unknown members of the United States Army who were then unarmed surrendered PoWs.

Verdict: Guilty, 2.

Sentences: Noack, Death by hanging.
Boess, Imprisonment for 8 years.
Confirmed.

Date & Place of Trial: 25th April 1946 at Ludwigsburg.

Verdict: Not guilty, 1.

Verdict: Guilty.
Sentence: Imprisonment for 18 months.
 Confirmed.
- 355) Trial of Friedrich Salzmann and 3 others, German nationals.
Date & Place of Trial: 5th - 24th April 1946 at Ludwigsburg.
Charge: That they wrongfully, wilfully and deliberately aided, abetted and participated in the killing of three members of the U.S. Army, whose exact identities were unknown, each of whom was then unarmed and a surrendered POW.
Verdict: Guilty, 4.
Sentences: Death by hanging, 2.
 Imprisonment for life, 2.
 Both death sentences commuted to imprisonment for life.

Date & Place of Trial: 27 July - 1 July 1946 at Dachau.
Charges: Wrongfully committing an assault on a member of the U.S. Army, a POW, and wrongfully encouraging, aiding, abetting and participating in the killing of an unknown member of the U.S. Army.
Verdict: Both guilty.
Sentences: Bodenstein, Imprisonment for life.
 Kuerschner, " " 20 years.
 Confirmed.

Date & Place of Trial: 10 October 1946 at Dachau.
Charge: Participation in an assault upon an unknown member of the U.S. Army, a POW.
Verdict: Both guilty.
Sentences: Imprisonment for 18 months, 2.
 Sentence against Eck disapproved. Eck discharged.
- 358) Trial of Jakob Schwarz, a German national.
Date & Place of Trial: 3 February 1947 at Dachau.
Charge: Committing an assault upon an unarmed, surrendered POW by hitting him in the face and body with his fists and attempting to shoot him.
Verdict: Guilty, with an exception.
Sentence: Imprisonment for 21 months, (from 19 May 1945).
 Prisoner released on 13 February 1947.

359) Trial of Matthias Zahnen, a German national.
 Date & Place of Trial: 15 - 16 May 1946 at Ludwigsburg.
 Charge: That he wilfully, deliberately and wrongfully killed an unknown member of the U.S. Army, an unarmed surrendered PoW by shooting him.
 Verdict: Guilty.
 Sentence: Imprisonment for 15 years.
 Disapproved. Prisoner released.

360) Trial of Karl Stoll, a German national.
 Date & Place of Trial: 6 January 1947 at Dachau.
 Charge: Committing an assault with a deadly weapon upon an American soldier, a PoW, by shooting him.
 Verdict: Guilty.

366) Trial of Josef Wolfgang Bablick and 6 others, German nationals.

Date & Place of Trial: 22nd October 1946 at Dachau.

Charge:(1) That, acting in pursuance of a common design and as individuals aiding the operation of the Dachau Concentration Camp and camps subsidiary thereto, did ... wilfully, deliberately and wrongfully participate in the subjection of civilian nationals of nations then at war with the then German Reich to cruelties and mistreatment, the names being unknown but the aggregate being many thousands.

(2) That they wilfully, deliberately and wrongfully participated in the subjection of members of the armed forces of nations then at war with the then German Reich who were...surrendered and unarmed prisoners of war in the custody of the then German Reich, to cruelties and mistreatment, the exact names and numbers of such prisoners of war being unknown but aggregating many hundreds.

Verdict: All accused guilty of both charges.

Sentences: Imprisonment for 2½ years, 1,

Sentences: Imprisonment for 2 years, 1,

371) Trial of Jiro Mizoguchi, and 6 others, Japanese nationals.

Verdict: Trial of Stepan Szeczynski (accused No.45) to be continued at a later date because of the delays involved in translating from French, Polish and other languages into Russian as well as English and German.

Charge: (2) As Charge 1, but the acts took place at Dachau, and concerned members of the armed forces of nations then at war with the then German Reich, who were then and there surrendered and unarmed prisoners of war in the custody of the then German Reich.
Verdict: Each accused guilty.

Shortly after the United Nations War Crimes Commission was created, it recommended to the Governments that National War Crimes Offices be established to investigate in the first instance reports concerning war crimes and to submit to the Commission in the form requested, charges concerning the offences investigated by them.

In response to the Commission's recommendation, Agencies of this kind were set up by all Governments, members of the Commission.

In the investigation of war crimes, and examination of charges submitted by the National Offices, the Commission, as an international organisation decided whether there was a case justifying the arrest and handing over for trial of the accused by the apprehending authorities who were thus not called upon to act upon ex parte statements by a single Government.

Cases filed with the Commission were, according to the Commission's rules of procedure, examined by Committee I (Committee on Facts and Evidence), in the presence of representatives of the Governments (National Offices) submitting the charges. The Commission then reported to the member Governments cases of war crimes in which there appeared to be either prima facie evidence sufficient to justify the apprehension and trial of individuals accused of war crimes, or else sufficient grounds to consider the wanted persons as suspects or material witnesses. This was the second stage of Committee I's work and in this respect the Commission has functioned in a manner resembling that of a committing magistrate, reporting to the Governments names of the individuals accused. This was done in the form of the Commission's Lists of War Criminals with which also all apprehending authorities concerned were supplied and thus were called upon to take the necessary action.

The present document covers only the statistical aspect of over four years work of Committee I composed of the following Members and their Deputies:

EXPLANATORY NOTE ON TABLES II - VIII.

The following Tables II and III, and consequently also Tables IV-VIII, have been set up on the basis of periodical Lists of War Criminals issued by the Commission and not upon the General Alphabetical Index of names. As all cases received by the Commission were being registered and examined by Committee I according to countries submitting them, the periodical Lists of War Criminals have been prepared accordingly, each of them including all persons or units charged by one country, irrespective of whether any of them might have been also charged by any other country. Some of them, in fact, have been charged several times. Therefore, the figures shown in Tables II and III do not represent the total number of persons and units actually listed in the General Alphabetical Index of War Criminals kept by the Commission. As the publication of such alphabetical and consolidated index must necessarily be deferred until the remaining Lists are issued, the total number of persons and units actually listed by the Commission to date is not available. Nevertheless, it may be safely assumed that the number of persons and units listed several times in the periodical Lists does not exceed 1% of the total figures in Tables II and III.

While arriving at the figures shown in Tables II-VIII, account has been taken of all changes and alterations in each List as indicated in subsequent Lists.

Repartition of Tables II and III according to individual countries submitting charges, and nationality of persons or units charged and listed, is shown in Tables IV-VIII.

Cases which have not been accepted by Committee I, and adjourned or withdrawn cases, are shown in Table X.
