SECRET ELLEO 371. GARDINER FROM ROLZ-BENNETT

HOFFACKER INFORMS ME THAT CORNAZ FINANCIAL ADVISER TO KIBWE IS LEAVING 3 MARCH FOR SHORT TRIP TO SWITZERLAND. HE IS INTERESTED IN TALKING TO FRASCA AND BADRE. HE KNOWS INSIDE OUT THE FINANCIAL SITUATION OF THE KATANGESE GOVERNMENT AND HAS PROBABLY BEEN INVOLVED IN PREPARING PROPOSALS TO TSHOMBE ON FINANCIAL AND ECONOMIC MATTERS FOR MEETING WITH ADOULA. HE FEELS IT WOULD NOT BE PROPER FOR HIM TO MEET FRASCA AND BADRE IN LEO BUT MEETING COULD BE ARRANGED AT BRAZZA. IF THIS IS AGREABLE HE WOULD HAVE TO GO TO LEO BY ONUC PLANE AND THENCE TO BRAZZA. TSHOMBE REPLIED HE WAS BUSY PREPARING FOR MEETING WITH ADOULA AND SHOWED ME SOME DOSSIERS ON FINANCIAL AND ECONOMIC PROBLEMS TO BE TAKEN UP AT MEETING. HE WAS DECIDED TO MEET ADOULA NOTWITHSTANDING ALMOST UNANIMOUS OPPOSITION FROM "HIS PEOPLE" BUT NATURALLY WANTED TO HAVE ASSURANCES CONCERNING HIS SECURITY. HE WAS NOT PERSONALLY AFRAID BUT "HAD RESPONSIBILITIES TOWARDS HIS PEOPLE". CONCERNING THE REOCCUPATION OF KONGOLO HE RECALLED HIS APPEALS TO UN TO SAFEGUARD AND PROTECT POPULATION AGAINST MUTINOUS AND UNDISCIPLINED ANC TROOPS AND HIS EARLIER OFFERS TO ESTABLISH COOPERATION BETWEEN GENDARMERIE AND ONUC FORCES TO PROTECT KONGOLO. THE ENTRY OF GENDARMERIE IN KONGOLO WAS DICTATED ONLY BY HUMANITARIAN REASONS AND THERE WAS NO INTENTION TO MOVE INTO OR ATTACK OTHER LOCATIONS. HE ASKED ME TO CONVEY TO ADOULA ASSURANCES THAT REOCCUPATION OF KONGOLO HAD NO AGRESSIVE DESIGN NOR SHOULD IT BE CONSTRUED AS A BEGINNING OF HOSTILITIES. RUMOUR THAT GENDARMERIE WOULD MOVE TO OTHER PLACES AS, FOR EXAMPLE, KABALO WERE ENTIRELY UNFOUNDED.

HE EXPLAINED THERE HAD BEEN NO BATTLE IN KONGOLO SINCE ANC ELEMENTS SIMPLY WITHDREW LEAVING EVERYTHING BEHIND INCLUDING VEHICLES, AMMUNITION AND EQUIPMENT. GENDARMERIE COULD HAVE EASILY PURSUED AND KILLED REMAINING ANC BUT REFRAINED FROM DOING SO. FOOD SUPPLIES AND MEDICINES BADLY REQUIRED BY POPULATION WERE BEING FLOWN IN. TURNING AGAIN TO MEETING IN LEO TSHOMBE SAID LATEST ADOULA STATEMENT NOT HELPFUL AND RATHER NEGATIVE. HE STATED SUCH STATEMENTS MAY CREATE UNPROFITIOUS ATMOSPHERE IN LEO. HE ATTACHED IMPORTANCE TO POINTS CONTAINED IN LETTERS TRANSMITTED BY ELLEO 327 AND AWAITED EARLY REPLY. REASSURED HIM EFFECTIVENESS AND EXTENT OF GUARANTEES ALREADY GIVEN TO HIM BY ONUC. HE WAS NOT AGGRESSIVE AND SEEMED TO BE RATHER WORRIED AND CONCERNED. ONE COULD SENSE THE PRESSURE BEING APPLIED ON HIM BY THOSE WHO OPPOSE HIS TRIP TO LEO BUT HE HIMSELF SOUGHT TO IMPRESS ON ME HIS DESIRE OF MEETING ADOULA.
