I HAVE HAD A MEETING THIS AFTERNOON WITH KIMBA ALONG WITH MSSRS
PECHE AND COATES CONCERNING THE ARRANGEMENTS TO BE WORKED OUT FOR
THE EVENTUAL CONTROL OF THE AIRPORT.

MR PECHE EXPLAINED TO KIMBA THAT AS FAR AS ICAO IS CONCERNED HE
SAW NO OBJECTION TO LOCAL KATANGESE PERSONNEL RESUMING
THEIR FORMER ACTIVITIES AT THE AIRPORT, MAINLY THE METEOROLOGICAL
SERVICES, RADIO OPERATORS AND THE AIRPORT MANAGER.
HOWEVER WE COULD NOT COME TO ANY AGREEMENT CONCERNING THE ACTUAL
