UNCLAS ALLEO 206 GARDINER FROM PERKOVIC INFO KHIARY . REPORT ABOUT INCIDENT WHICH HAPPENED IN ALBERTVILLE ON 6 MARCH 62. YESTERDAY 6 MARCH BEFORE 1400 HOURS MR DANIAL FITZPATRICK JR MECHANIC BELONGING TO AIR PANAMA WAS IN THE BAR IN FRONT OF ONUC HQ TO TAKE SOME FOOD. FIVE MINUTES AFTER AN ANC SOLDIER STARTED TO SPEAK VERY FAST AND LOUD TO HIM AND HE DIDNT UNDERSTAND HIM. SOMEBODY ASKED MR FITZPATRICK TO PRODUCE HIS ID CARD BUT IN ALL THIS CONFUSION HE COULDNT EXPLAIN THAT HIS PAPERS WERE AT ONUC HQ WHERE HE IS ACCOMMODATED IN AYE TRASIENT ROOM. ONE OTHER ANC SOLDIER TRIED TO EXPLAIN TO MR FITZPATRICK TO GET AWAY BECAUSE THER^E WOULD BE CFN 206 6 62 6 1400

TROUBLE . IN SPITE OF MR FITZPATRICKS DECLARATION IN HIS POOR FRENCH THAT HE WAS AYE MEMBER OF ONUC, CONGOLESE SUSPECTED HIM OF BEING AYE MERCENARY. MR FITZPATRICK LEFT THE BAR AND WENT STRAIGHT TO ONUC HQ BEING FOLLOWED AND SHOUTED AT. WHEN HE ARRIVED INSIDE AYE FEW MINUTES LATER SOME CONGOLESE PENETRATED INTO ONUC HQ AND TRIED TO PULL HIM OUT. FOR THE TIME BEING WE HAVE NOT AYE PERMANENT GUARD TO PROTECT OUR HQ BUT CANADIAN SIGNALS ARE ACCOMMODATED IN THE SAME BUILDING AND THEY INTERVENED IN THE MATTER TO HELP MR FITZPATRICK. THE CANADIANS SUCCEDED IN SAVING MR FITZPATRICK BUT HIS SHIRT AND TROUSERS WERE COMPLETELY TORN DURING THE SCUFFLE. AS EYE ARRIVED AT 1405 HOURS EYE FOUND AYE MALAYAN PLATOON IN DEFENSIVE POSITION AROUND THE HQ AND THE CROWDS SHOUTING QOUTE MERCENARY MERCENARY UNQUOTE. EYE TOOK THE DISTRICT COMMISSIONER AND MBAKULU RAPHEAL, SECURITY COMMISSIONER, INTO MY OFFICE TO INVESTIGATE THE CASE WINT THEM. EYE CALLED IN MR FITZPATRICK WHO PRODUCED HIS AMERICAN PASSPORT NO 165603 ESTABLISHED 13 JAN 62 BY AMERICAN AUTHORITIES. HE HAD IN HIS PASS PORT THE STAMP IMMIGRATION LEO AERO OF 21 FEB 62. HE HAS ALSO THE VISA DE VOYAGE NO 129 VALID FROM 8 FEB 62 TO 8 MAY 62 DELIVERED IN NEW YORK BY DELEGATION OF REPUBLIC OF CONGO PERMANENT MISSION TO THE UNITED

NATIONS. EYE SHOWED ALL THIS DATA TO CONGOLESE AUTHORITIES AND TOLD THEM THAT THE GENTLEMAN WAS PERFECTLY IN REGULATION AND THAT THIS KIND OF INCIDENT WAS INADMISSABLE. EYE COULDN'T FIND MR SENDWE THAT SAME DAY BUT EYE CONTACTED HIM THIS MORNING AND INTRODUCED AYE PROTEST FOR SUCH KIND OF CARRYING ON. HE ANSWERED THAT ACCORDING TO HIM THE WHOLE ONUC FLYING PERSONNEL SHOULD HAVE ONUC ID CARDS. EYE EXPLAINED THAT EYE WASN'T AWARE THAT ONUC PROVIDED SUCH DOCUMENTS FOR CHARTED AIRCREWS. THE DISTRICT COMMISSIONER, MWAMBAIE JEREMIE, WHO WAS IN SENDWE'S OFFICE AT THE TIME, ASKED ME TO PROVIDE HIM WITH INFORMATION ON ALL ONUC PERSONNEL ARRIVING IN ALBERTVILLE WITH ONUC AIRCRAFTS. THIS EYE REFUSED CATEGORICALLY EXPLAINING THAT WE TAKE THE WHOLE RESPONSIBILITY FOR OUR PERSONNEL. EYE AGREED AS WE DID IN THE PAST TO NOTIFY HIM OF ARRIVAL OF ALL NON ONUC PASSENGERS VIA UN AIRCRAFT. EYE REQUESTED IN FUTURE TO INSTRUCT CONGOLESE LOCAL AUTHORITIES IN ALBERTVILLE TO EXERCISE THEIR JOB IN AYE MORE PLEASANT MANNER WHICH MR SENDWE PROMISED ME TO DO. NEW SUBJECT: MR THOMAS LUCIEN ID 1806 ICAO TECHNICIAN ARRIVED ALBERTVILLE MARCH 7 62.

SETRA-CONGO FROM USUMBURA HAVE NOTIFIED US THAT CFL ALBERTVILLE ARE HOLDING FOR THEM 20 TONS EXPLOSIVES AND LARGE NUMVERS OF DETONATORS AND FUSES VERY URGENTLY NEEDED FOR THEKNES IN RUANDA.
