S E C R E T ELLEO 490 GARDINER ROLZ-BENNETT FROM BACK.

THIS MORNING AT 8 AM A UNIVERSITY BUS^S CARRYING STUDENTS AND ONE PROFESSOR AND DRIVING TOO FAST HIT AND UPSET BARREL AT KASAPA ROADBLOCK. INDIAN SENTRY STOPPED BUS AND REQUESTED DRIVER TO SET UP BARREL AGAIN. DRIVER REFUSED. SENTRY REMOVED HIM FORCIBLY FROM SEAT AND HE WAS SLIGHTLY MANHANDLED, FALLING IN THE MUD AND HAVING HIS SHIRT TORN. UN SECURITY INVESTIGATED AND LATER COLONEL KIEMBE MICHEL, CHIEF OF STAFF OF GENDARMERIE CALLED ONUC CHIEF OF STAFF TO INFORM HIM OF INCIDENT. CHIER OF STAFF MET KIEMBE AT ROADBLOCK AND AFTER CLOSE INSPECTION KIEMBE ADMITTED THAT DRIVER WAS AT FAULT. BOTH MILITARY SIDES AGREED TO CONSIDER INCIDENT AS CLOSED. HOWEVER LETTER FROM VICE-RECTEUR OF UNIVERSITY SENT TO YOU IN UNCLAS WAS RECEIVED THIS AFTERNOON. MOREOVER A BRIEF DEMONSTRATION BY STUDENTS LED PRESUMABLY BY JENAKAT TOOK PLACE IN TOWN THIS AFTERNOON WITH ANTI-UN SIGNS. POLICE WAS WARNED AND PROMISED THAT DEMONSTRATORS WOULD NOT BE ALLOWED TO COME CLOSE TO HEADQUARTERS. NECESSARY PRECAUTIONS WERE TAKEN ON OUR SIDE. GHALEB CONTACTED VICE-RECTEUR TO EXPLAIN HIM THAT KIEMBE HAD ADMITTED DRIVERS FAULT AND THAT HE HAD ALSO INFORMED MINISTER KIMBA THROUGH MME VERMEULEN.

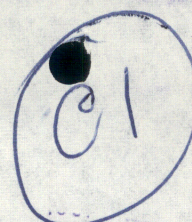
