I REPLIED THAT I HAD NOT YET SEEN RELEASE AND THAT I WAS SURE UNATIONS MEMBERS OF JOINT COMMISSION WOULD TAKE STRONG EXCEPTION AT MEETING FORESEEN FOR TOMORROW OF JOINT COMMISSION AS RELEASE HAD BEEN HANDED TO PRESS PRIOR TO THEIR BEING INFORMED OF IT. ON SUBSTANCE OF RELEASE I QUOTE TERMS OF REFERENCE OF JOINT COMMISSIONS WHICH HAD BEEN ENTRUSTED WITH IMPLEMENTING GENASSEMBLY ANE SECCO RESOLUTIONS CONCERNING WITHDRAWAL AND IMMEDIATE EVACUATION OF ALL MERCENARIES AND PARAMILITARY PERSONNEL. I STRESSED THAT REQUEST TO VISIT KABALO WAS NOT WITHIN ABOVE TERMS OF REFERENCE AND THAT THEREFORE UNATIONS MEMBERS OF COMMISSION HAD REFUSED TO ACCEDE TO IT AS OBVIOUSLY THERE WERE NO KATANGESE FORCES PRESENT IN KABALO. I EMPHASIZED THAT UNATIONS MEMBERS HAD REPEATEDLY REQUESTED COMMISSION TO GO TO KOLWEZI BUT TO NO AVAIL

FURTHER TO ELLE0557 AND 559. NGOI AND BANZA SAW LEADERS OF REFUGEE CAMP SATURDAY MORNING AT TUNISIAN COMMANDERS HOUSE ON OCCASION OF WEEKLY MEETING WHICH COMMANDER HAS WITH THEM. MAIN POINTS OF KAMITATUS LETTER TRANSMITTED TO MUTAKA ON 14 APRIL VIA KIMBA(KG49 AND 50). MUTAKA RETURNED ELI SATURDAY NIGHT AND CALLED FULCHERI SUNDAY MORNING. HAD NOT RECEIVED OUR LETTER YET AND WAS INFORMED ARRIVAL AND FUNCTIONS OF NGOI AND BANZA WHOM HE SAID HE WOULD SEE AT TSHOMBES RESIDENCE AT 2 O'CLOCK THE SAME DAY. UPON BEING INFORMED OF MESSAGE NGOI AND BANZA REFUSED TO GO TO TSHOMBES RESIDENCE AND ASKED THAT MUTAKA SHOULD INVITE THEM OFFICIALLY AND IN WRITING TO GO TO SEE HIM IN A PLACE WHERE UN PROTECTION COULD BE ASSURED. THEY ALSO REFUSED TO SPEAK TO MUTAKA ON TELEPHONE. I CALLED MUTAKA AT 1330 HOURS AND PUT UN HEADQUARTERS AT HIS DISPOSAL WHICH HE REFUSED, BUT AFTER LONG DISCUSSION AGREED THAT MEETING SHOULD BE HELD AT ASSEMBLY BUILDING AT AN HOUR WHICH WE WOULD COMMUNICATE TO HIM AFTER HAVING CONTACTED LEO DELEGATES. THEY AGREED TO MEET MUTAKA AND DROPPED REQUEST FOR OFFICIAL INVITATION. FULCHERI CALLED MUTAKA AT HOME AND TSHOMBES RESIDENCE 5 TIMES BETWEEN 1350 AND 1440 HOURS AND GOT MADAME VERMEULEN TWICE, WHO TOLD HIM AT 1420 HOURS THAT MUTAKA WAS WITH KIMBA. AT 1440 AN

IRATE MUTAKA CALLED FULCHERI SAYING THAT HE HAD BEEN WAITING AT THE ASSEMBLY AND NOBODY HAD SHOWN UP, AND THEREFORE HE WOULD NOT SEE DELEGATES THAT DAY UNLESS THEY WENT TO RESIDENCE. HE WENT INTO A TIRADE AGAINST THE UNION AND THE CENTRAL GOVERNMENT AND WAS STOPPED SEVERAL TIMES WHEN HE TRIED TO DISCUSS SUBSTANCE OF KAMITATUS LETTER WHICH HE CLAIMED HE HAD NOT RECEIVED YET. LEO DELEGATES INFORMED THAT MEETING TEMPORARILY POSTPONED AND THEY ONCE MORE REFUSED TO GO TO RESIDENCE BUT AGREED TO SPEAK TO MUTAKA ON TELEPHONE. HOWEVER ALL ATTEMPTS TO CONTACT MUTAKA OF KIMBA FAILED AND IT WAS ONLY AT 2030 HOURS THAT MUTAKA CALLED FULCHERI AGAIN. MUTAKAS MOOD WAS MUCH MORE PEACEFUL AND HE MADE FOLLOWING POINTS.

A. PROVINCIAL ASSEMBLY HAD DELEGATED ALL POWERS TO TSHOMBE FOR DISCUSSION, RESERVING THE RIGHT OF RATIFICATION. ARRIVAL OF LEO DELEGATES WHO ARE NOT MEMBERS OF PROVINCIAL ASSEMBLY BUT DELEGATES OF CENTRAL GOVERNMENT MADE HIM WONDER WHETHER TSHOMBE HAD NOT TAKEN DECISIONS BEYOND HIS MANDATE, DECISIONS WHICH WOULD BE ILLEGAL, OR ELSE ADOULA WAS TRYING TO DICTATE UNACCEPTABLE AND ILLEGAL CONDITIONS TO KATANGESE ASSEMBLY.

B. IN ORDER TO PROVE HIS GOOD WILL HE WAS READY TO SEE DELEGATES AT 0900 HOURS MONDAY MORNING AT ASSEMBLY BUILDING. HE WOULD BE ACCOMPANIED BY SOME ASSEMBLY MEN AND ESCORTED BY QUOTE PARA COMMANDOS AND GENDARMERIE UNQUOTE.

C. HE WOULD LIKE TO SPEAK TO LEO DELEGATES ON PHONE IN ORDER TO ASSURE THEM THAT THEY WERE AMONG THEIR BROTHER AND HAD NOTHING TO FEAR.

LATER I CALLED MUTAKA WHO GAVE ME SAME STORY AND WARNED HIM THAT NO ARMED PARACOMMANDOS AND GENDARMES COULD BE ADMITTED IN TOWN BUT THAT WE WOULD HAVE NO OBJECTION TO HIS BEING ACCOMPANIED BY USUAL ESCORT SAME EVENING LEO DELEGATES FINALLY AGREED TO PHONE MUTAKA AND HAD FRIENDLY AND LENGTHY CONVERSATION.

ON MONDAY MORNING KIMBACALLED ME UP TO DISCUSS MUTAKAS ESCORT AND IT WAS AGREED SUCH ESCORT WOULD BE THE USUAL ONE.

AT 0900 HOURS NGOI AND BANZA ACCOMPANIED BY FULCHER 2 SECURITY OFFICERS AND 10 INDIAN SOLDIERS IN 2 JEEPS WENT TO ASSEMBLY BUILDING. MUTAKA ARRIVED 0910 HOURS WITHOUT ESCORT AND ACCOMPANIED BY 2 ASSEMBLY MEN. OUR PEOPLE LEFT BUILDING AND WAITED OUTSIDE WHILE MEETING WAS GOING ON. MEETING STARTED AT 0912 HOURS AND ENDED AT 1040. LATER ON BANZA TOLD FULCHER THAT CONVERSATION HAD BEEN FRIENDLY AND THAT AMONG POINTS RAISED WERE FOLLOWING.

A. QUOTE LE CONCLAVE UNQUOTE TO WHICH MUTAKA IS FIRMLY OPPOSED SINCE QUOTE IT IS A VIOLATION OF HUMAN RIGHTS UNQUOTE.

B. MUTAKA LABELLED KAMITATUS INITIATIVE AS ILLEGAL SINCE ONLY PRESIDENT OF PROVINCIAL ASSEMBLY CAN CONVENE MEETING.

C. NO MEETING OF ASSEMBLY COULD BE CONVENED DURING TSHOMBES ABSENCE. MEETING WILL BE QUOTE LA REUNION DE LA RECONCILIATION UNQUOTE FROM WHICH A GOVERNMENT INCLUDING MEMBERS OF CARTEL WOULD COME OUT AND ONLY TSHOMBE COULD DO THE RESHUFFLE.

D. MUTAKA IS NOT COMPLETELY OPPOSED TO MEETING IN KAMINA. BUT ONCE MORE BRANDED INITIATIVE BY KASAVUBU IN THIS DIRECTION AS ILLEGAL. OBJECTION AGAINST COMING SESSION IN KAMINA IS THAT

E. HE WANTS ASSEMBLY TO MEET AND STATES THAT SECURITY OF  
OPPOSITIONS ASSEMBLYMEN WOULD NOT BE IN DANGER.

PARA AFTER MEETING, LEO DELEGATES ACCOMPANIED BY 2 UN SECURITY  
OFFICERS WENT TO DRINK BEER IN TOWN WITH GROUP OF KATANGESE  
WHICH INCLUDED TSHOMBES BROTHER, THE FIRST VICE-PRESIDENT AND  
SECRETARY GENERAL OF ASSEMBLY.

PARA IN AFTERNOON, NGOI AND BANZA VISITED REFUGEE CAMP. A HUGE,  
IMPRESSIVE AND ORDERLY CROWD WELCOMED THEM AND SEVERAL HUNDRED  
JEUNESSE DRESSED IN TRIBAL CLOTHES AND PAINTED WITH TRIBAL  
SYMBOLS PARADED WITH MACHETES, CADENCES, FAKE WEAPONS AND  
CONGOLESE FLAGS. MANY SIGN BOARDS WERE ALSO SEEN APPLAUDING  
CONGOLESE UNITY, ADOULA, SENDWE, GIZENGA AND LUMUMBA. SONGS  
WERE SUNG IN WHICH NAMES OF SENDWE, GIZENGA AND LUMUMBA COULD

THIS MORNING MAJOR LINDEGARD SEMO AND LT HOUG OF BASE HOSPITAL BOTH FROM KAMINA WERE ARRESTED BY KATANGESE WHEN THEY WENT INTO TOWN. THEY LOST THEIR WAY AND AT 1030 HRS WERE PICKED UP BY GEND AT ONE OF THEIR ROADBLOCKS IN AREA OF LUBUMBASHI COMMUNE.
