IT WOULD BE GREATLY APPRECIATED IF YOU WERE TO SEND SIGNAL TO CAPTAIN CIPOLAT, OFFICER IN CHARGE OF THE ONUC ITALIAN HOSPITAL IN ELISABETHVILLE, AND HIS STAFF THANKING AND CONGRATULATING THEIR DEDICATED WORK AT ALL TIMES BUT PARTICULARLY LAST FEW DAYS HANDLING THE REFUGEES CAMP VICTIMS. THEY HAD BEEN WORKING UNTIL 3 AND 4 O'CLOCK IN THE MORNING ON MAJOR OPERATIONS AND THEY HAVE SAVED MANY ~~XXX~~ LIVES. AT THE SAME TIME COULD SOMEBODY SEE THAT THEY GET THE MEDICAL SUPPLY THEY HAVE ASKED FOR. A TELEGRAM QUOTE NO 1 PHARMACY ONUC UNQUOTE TO SMSO LEOPOLDVILLE TODAY REFERS. ON OCT 16 THEY HAVE ORDERED 4500 UNITS OF SILK FOR STITCHES AND THEY WERE SENT ONLY 30. THE NEW SUPPLIES WHICH CAME IN AT THE HEIGHT OF THEIR WORK DURING THE LAST FEW DAYS AGAIN CONTAINED NO SILK ON THE GROUNDS QUOTE THAT IT HAD BEEN INDENTED IN OCTOBER UNQUOTE. THEY ARE COMPLETELY OUT OF THE RIGHT TYPE OF SILK AND ON DELICATE OPERATIONS TODAY THEY WERE USING A TYPE WHICH MADE THE WORK DOUBLY DIFFICULT. FURTHERMORE CIPOLAT HAS BEEN UNABLE TO PURCHASE ANY LOCALLY. SOME SIMILAR EXPERIENCES IN THE PAST HAVE PROVED DISCOURAGING TO THESE EXCELLENT PEOPLE. IN ADDITION CAPTAIN CIPOLAT HAS NO TRANSPORT. REGARDS.



S E C R E T ELLEO 132 LINNER KHIARY FROM CRUISE OBRIEN. EYE SAW KIMBA X TODAY AT HIS REQUEST AND HAD A FRANK AND CORDIAL CONVERSATION OF ABOUT 2 HOURS WITH HIM. HE WAS WORRIED ABOUT THE SITUATION IN NORTH KATANGA WHICH HE WISHES TO VISIT. EYE GAVE HIM AN OUTLINE OF THE SITUATION IN THE NORTH AND IT BECAME APPARENT THAT HE WAS AWARE THAT THE CENTRAL GOVT COULD IF IT WISHES INSTALL ITSELF IN A LARGE REGION OF THE NORTH. EYE MADE IT PLAIN TO HIM THAT THE UN COULD NOT OPPOSE THIS DEVELOPMENT IF IT WERE DEMANDED BY THE CENTRAL GOVT AND DESIRED BY THE POPULATION. EYE EMPHASIZED THAT THE REAL PROBLEM DID NOT LIE IN NORTH KATANGA OR ANY OTHER SPECIFIC REGION BUT LAY IN THE FACT THAT THE CONSTITUTIONAL PROBLEM REMAINS UNSOLVED FOR LACK OF CONTACT AND AGREEMENT BETWEEN THE CENTRAL AND THE PROVISIONAL GOVT. EYE PROPOSED THAT FAILING PRESIDENT TSHOMBE HE HIMSELF SHOULD GO TO LEO. AS REGARDS AVILLE AND OTHER NORTH KATANGAN CENTERS EYE TOLD HIM THAT WE WOULD AGREE TO ONE OF THE JOINT SUB COMMITTEES TO WHICH HE HAD JUST NOMINATED THEIR REPRESENTATIVES SHOULD GO THERE ASSUMING THAT OTHERS WILL VISIT KOLWEZI, KIPUSHI ETC. SUCH VISITS WOULD HOWEVER BE OF LITTLE USE UNLESS PROGRESS WAS MADE WITH THE CENTRAL GOVT. KIMBA AGREED WITH MOST OF THIS AND INDICATED THAT IN THE PROVINCIAL GOVT HE WAS THE PARTISAN OF AGREEMENT WITH THE CENTRAL GOVT WHICH OTHER MEMBERS DID NOT WANT AT ANY PRICE. EYE HAVE THE IMPRESSION FROM HIS REMARKS THAT HE AND PERHAPS MOST OF HIS COLLEAGUES SEE THE IMPORTANCE OF SECURING A SETTLEMENT BUT THAT THEY ARE RATHER FRIGHTENED BY THE BITTERNESS AND EXTREMISM OF SOME OF THEIR COLLEAGUES INCITED BY FOREIGN ELEMENTS
