Also that extension of Larsen's appointment to 30 June 1964 is not repeat not assurance that his services would not be terminated prior to that date depending on service requirement. Unquote. In these circumstances ONUC can only agree that Mrs. Larsen comes to Congo at Larsen's expense and if she arrives in December, stays until end June and that Larsen's contract not terminated earlier, he could claim reimbursement.




