I GOT IN TOUCH WITH ADOULA TO WHOM I TRANSMITTED GIST OF ABOVE CABLE IN OFFICIAL LETTER FORM THIS MORNING AND IT HAD BEEN AGREED THAT I SHOULD MEET HIM BEGINNING OF THIS AFTERNOON SINCE HE HAD SERIOUS RESERVATIONS PARTICULARLY AS WE GOT POINT 2. OVER THE TELEPHONE ADOULA INDICATED KATANGA DEPUTIES AND SENATORS SHOULD REMAIN HERE FOR DURATION OF PARLIAMENTARY SESSION.

ADOULA HAS NOW CALLED CANCELLING SCHEDULED MEETING BECAUSE HE HAS TO ATTEND A COUNCIL OF HIS MINISTERS. I WILL TRY AND SEE HIM EITHER LATE TONIGHT OR EARLY TOMORROW MORNING.

IN THE MEANTIME I HAVE RECEIVED FROM IVAN SMITH A FURTHER MESSAGE IN WHICH HE QUOTES THE TEXT OF THE REPLY WHICH HE HAS ADDRESSED TO TSHOMBE AND WHICH HAD BEEN DELIVERED PERSONALLY BY THE US CONSUL.



1. Only rice is immediately available, other commodities being unprocurable here until Tuesday. Troop rotation and other military priorities limit the possibility of airlift. However two DC4's, identifications RIC flight number 930 ETA 1230Z and IAL flight number 929 ETA 1400Z each carrying 120 sacks rice arriving tomorrow Sunday. Please delegate someone to meet these aircraft and make all necessary arrangements to ensure safe delivery to FORSLUND.
2. Americans are critical of the use of airlift when at Washington and embassy levels they have cleared away all restriction on United Nations using the stocks held by Robinson. United States has retaken title to those supplies and Hoffaker has been told he may turn them over to UNOC. They would have raised no objection had you simply seized the goods. It appears therefore that you could utilize these supplies by arrangement between you and Hoffaker and that this is no longer a matter for discussion between Robinson and Tshombe. Please seek Hoffaker's views on this and cable urgently firm possibilities acquisition these supplies.
- 3; Provision of civilian camp staff must wait on implementation of comprehensive plan. We have no civilian personnel here immediately available of types that would be useful to Forslund. Vieira has left and Moutier is not available. We have been advised that Gussing, now directing camp for Algerian refugees in Tunisia, has been made available to direct the cleanup of the camp and will arrive soonest. I expect him to be briefed by New York and provided with necessary resources in staff, supplies and funds.

" The following based on information from Bunch being issued today as S/5038: Quote Report of the Secretary-General concerning the negotiations at Kitona between Prime Minister Cyrille Adoula and Mr. Tshombe

1. Following a request by Mr. Moise Tshombe contained in a telegram to the President of the United States of America on 14 December 1961, a meeting was arranged at Kitona, in Leopoldville Province, between Prime Minister Cyrille Adoula and Mr. Tshombe with the assistance of United States Ambassador Edmond Gullion and the United Nations Organization in the Congo. Mr. Gullion brought Mr. Tshombe and his party to Kitona from Ndola in a United States aircraft on the morning of 19 December. Mr. Adoula and his party were flown to Kitona in a United Nations aircraft later on the same day. Para 2. The day before, the Acting Secretary-General had announced that if the immediate objectives of the United Nations Force in Elisabethville were achieved and if firm arrangements were actually being made for Mr. Tshombe to fly to Kitona, he would order ONUC troops in Katanga to hold their fire for the duration of any talks between Prime Minister Adoula and Mr. Tshombe with, of course, the right to act in self defence in case they were attacked during the period of the parley. In accordance with this announcement, the ONUC Command in Elisabethville ordered a hold-fire at 7 A.M. on

.../...

late hours fatigue caused a number of heated exchanges. After a good deal of difficulty had been overcome, an agreement was arrived at outside the meeting room on 21 December 1961 at approximately 2:30 A.M. Para 7. The agreement consists of a declaration by Mr. Tshombe, a letter from him to Mr. Bunche, and letters from Mr. Bunche to the Provincial President and to the Prime Minister, as follows:(text as sent follow).

8. It will be noted that in his declaration Mr. Tshombe states his position without reservation Para 9. At approximately 3 .M. both Delegations gathered in the meeting room for brief courtesy statements. Mr. Bunche expressed gratitude on behalf of the Secretary-General, and Ambassador Gullion, on behalf of the United States Government. The parley having concluded in a cordial atmosphere, the Delegations departed immediately in their respective aircraft Para. 10. A detachment from the Nigerian Contingent of ONUC was responsible for special security arrangements at Kitona during the conversations. These duties were discharged with efficiency. Unquote."

19 December Para 3. The parties gathered for their first formal meeting at 8:30 A.M. on 20 December 1961, with the Delegations of the Central Government and the Provincial Government only being present. Robert Gardiner, Mahmoud Khatib and Georges Dumontet Para The Prime Minister and Mr. Tshombe explained their positions, the former stressing observance of the Loi Fondamentale, and the latter stating that he accepted it Quote In principle Unquote. Being asked to comment at this point Mr. Bunche appealed to the parties not to abandon their efforts until agreement between them had been reached. A similar appeal was made by Ambassador Guillon Para 6. Procedural and substantive differences between the Delegations became evident as the conversations continued, and a number of different approaches and formulations had to be devised in the course of the day-long effort to find a basis for agreement. "Le Secrétaire général par intérim des Nations Unies présente ses compliments à M. le Représentant Permanent de la Belgique auprès de l'Organisation et, se référant à sa note verbale S.2683 du 13 décembre 1961, a l'honneur de porter à sa connaissance que dès réception de la communication du Représentant permanent, il a prié le fonctionnaire chargé de l'opération des Nations Unies au Congo de faire procéder aux enquêtes voulues. L'incident en question s'est produit à Shinkolobwe, camp de gendarmerie situé dans les faubourgs de Jadotville et l'un des principaux points où la Gendarmerie katangaise et les mercenaires se rassemblaient pour leurs opérations contre les troupes de l'ONUC. Shinkolobwe continuant à être utilisée à cette fin, la Force des Nations Unies a été obligée de déclencher contre elle une attaque aérienne. L'hôpital est situé à l'intérieur de l'enceinte du camp, à 200 mètres environ du bâtiment principal. Selon le rapport de l'officier de l'ONUC qui dirigeait l'attaque aérienne, aucun insigne de la Croix-Rouge n'était visible à 2500 mètres d'altitude; une croix indistincte brun rouge, sur le toit de l'un des bâtiments, a été aperçue au cours de l'attaque alors que les appareils de l'ONU étaient déjà descendus à 200 ou 300 mètres d'altitude. L'ordre de cesser l'attaque a été donné dès que la Croix Rouge a été aperçue de l'un des appareils, mais certains d'entre eux avaient déjà commencé à tirer, atteignant, semble-t-il, l'hôpital. Il n'y a pas de village à l'extérieur du camp et il n'y a pas d'autres

bâtiments à proximité; il semble donc que c'est par erreur que la note du Représentant permanent fait mention d'un "marché". Le Secrétaire général par intérim regrette vivement les pertes de vies humaines, les blessures et les dommages causés par l'attaque des appareils de l'ONU, qui, alors qu'ils s'attaquaient légitimement à un objectif militaire, paraissent avoir atteint aussi un hôpital. Il a donné pour instructions au commandement de l'ONU de veiller à ce que les plus strictes précautions soient prises pour éviter, autant que cela est humainement possible, la répétition de tels incidents."

SINCE, HOWEVER, IT TAKES TWO TO MAKE A QUARREL, WOULD IT BE POSSIBLE FOR SPAAK TO ADDRESS AN APPEAL TO HIS COMPATRIOTS IN ELISABETHVILLE AND ASK THEM NOT TO INDULGE IN ANY PROVOCATIVE ACTION WHICH MAKES IT NECESSARY FOR ONUC TO RETALIATE? WE TOLD HIM THAT IF SPAAK WAS WILLING TO ADDRESS SUCH AN APPEAL IT COULD BE TIMED SIMULTANEOUSLY WITH PUBLIC REITERATION OF DIRECTIVE TO ONUC TO HOLD THEIR FIRE EXCEPT WHERE THEIR OWN SAFETY DEMANDS THAT THEY RETALIATE.
