Dear Colleagues,

I would like to thank you for your letter dated 11 January 2009, expressing your concern over the suffering of the civilian population in Gaza and the number of civilian casualties during the fighting there.

Much like you, I was deeply concerned over the situation in Gaza and the heavy price being paid by the civilian populations. I repeatedly called for an immediate end to the violence, and I expressed my condemnation of the excessive use of force by Israel as well as the rocket and mortar attacks by Hamas and other Palestinian militants. I called on all concerned parties to comply fully with international human rights and humanitarian law.

As you know, I travelled to the region on 13 January 2009 to underscore the urgent need to reach an immediate ceasefire and to implement Security Council resolution 1860 (2009). During my trip, I held talks with the leaders of Egypt, Jordan, Israel, the Palestinian Authority, Turkey, Lebanon and Syria, as well as with regional and international leaders at a meeting convened by President Mubarak in Sharm el-Sheikh and at the Arab Economic Summit in Kuwait.

On 20 January 2009, I visited Gaza to inspect the extent of the destruction, and to pledge the support of the United Nations and its commitment to the continued provision of humanitarian assistance and a concerted early reconstruction effort. I also wanted to personally visit and thank United Nations staff who worked steadfastly during the crisis, in great danger, and to pay tribute to those killed and injured.

In the aftermath of my visit, the United Nations launched a Flash Appeal for humanitarian assistance, and will work, in concert with other concerned actors, to ensure that humanitarian needs in Gaza are addressed fully and rapidly, and that a coordinated early reconstruction effort begins soon, with the full support of the international community.

During and after my visit to Gaza, I also made clear that attacks such as the repeated shelling and destruction of United Nations facilities are unacceptable. I protested such attacks in the strongest possible terms and demanded a thorough investigation into each of these incidents. I expect to receive a full explanation of each incident and that those responsible will be held accountable for their actions. In the meantime, I am initiating a United Nations Board of Inquiry into the casualties and damage at the Gaza facilities of both the United Nations Relief and Works Agency for Palestine Refugees in the Near East and of the United Nations Special Coordinator Office for the Middle East. I have also raised with the Security Council the issue of an enquiry into the broader question relating to the conduct of the parties to this conflict during the hostilities.

I wish to assure you that the United Nations will continue its efforts to help bring about a durable ceasefire arrangement, and to contribute to the achievement of our ultimate goals: the ending of the occupation that began in 1967, the establishment of a Palestinian state and its coexistence in peace and security alongside Israel, with the attainment of a just, lasting and comprehensive peace between Israel and all its Arab neighbours, based on relevant Security Council resolutions.

In closing, I would like to pay tribute to all of you, our colleagues of the United Nations family in Syria, and to thank you for your important work in service to the Organization. I hope you will join me in our efforts to help bring about peace and security for all peoples in the Middle East.

We, the representatives of the staff associations of all International Organizations and UN agencies based in Syria, express our dismay and indignation at the targeting of civilians during recent attacks in Gaza. We are seriously alarmed by the increasing numbers of casualties amongst civilian population.

As international civil servants bound by the UN charter and all pertinent UN Security Council resolutions in upholding international humanitarian and human rights law, we reaffirm our position that all civilians, especially women and children, should be protected.

As we support and urge your continued efforts to put an end to violence in Gaza, we voice our fear of the continued hardship and suffering faced by the innocent population in attaining their right to live and to have the basic needs.

We mirror the daily demonstrations demanding the UN to take a stronger stand in resolving the current critical situation, to stop the aggression against civilians and to enable the timely delivery of humanitarian assistance.
