Señor Jefe de Gabinete:

Tenemos el honor de hacerle llegar copia de la carta conjunta remitida al Secretario Ejecutivo de la Convención Marco de Naciones Unidas sobre Cambio Climático por España, en su condición de Presidenta de turno del Consejo de la Unión Europea, y por la Comisión Europea, por medio de la cual se expresa la voluntad de la Unión Europea y la de sus 27 Estados Miembros de asociarse al Acuerdo de Copenhague.

Esta carta quiere igualmente reafirmar el compromiso de la Unión Europea y sus 27 Estados Miembros en la lucha contra el cambio climático con el objetivo estratégico de mantener el incremento global de la temperatura por debajo de los dos grados centígrados y limitar, por consiguiente, el incremento de las emisiones de gases de efecto invernadero hasta reducirlos a niveles inferiores a los existentes en 1990. Con esta finalidad, la UE mantiene su propósito de seguir vinculada al proceso negociador que, en el marco de las Naciones Unidas, nos permita adoptar un acuerdo jurídicamente vinculante con efectos a partir del 1 de enero de 2013.

Aprovechamos esta oportunidad para reiterarle, señor Jefe de Gabinete, el testimonio de nuestra más alta y distinguida consideración.

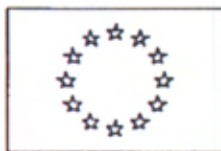

Subject: Expression of willingness to be associated with the Copenhagen Accord and submission of the quantified economy-wide emissions reduction targets for 2020

Dear Mr. de Boer,

With this letter, Spain, currently holding the Presidency of the Council of the **European** Union, and the European Commission wish to inform you, on behalf of the EU and its 27 Member States, that the EU and its 27 Member States are willing to be associated with the Copenhagen Accord (Note Verbale of the Permanent Mission of Denmark to the United Nations on **30** December 2009 and your **notification** to Parties on 18 January 2010).

The EU and its 27 Member States wish to reconfirm their commitment to a negotiating process in order to achieve the strategic objective of limiting the increase in global average temperature to below 2°C above pre-industrial levels. Meeting the 2°C objective requires that global GHG emissions peak by 2020 at the latest and be reduced by at least 50% as compared with 1990 levels by 2050 and continue to decline thereafter. To this end, and in accordance with the findings by the IPCC, developed countries as a group should reduce their GHG emissions below 1990 levels through domestic and complementary international efforts by 25 to 40% by 2020 and by 80 to 95% by 2050 while developing countries as a group should achieve a substantial deviation below the currently predicted emissions growth rate, in the order of 15-30% by 2020. The EU and its 27 Member States are fully committed to continue negotiating with the other Parties with a view to concluding as soon as possible within the UN framework a legally binding international agreement for the period starting 1 January 2013.

The EU and its Member States are committed to an independent quantified economy-wide emissions reduction target of 20% by 2020, compared to 1990 levels. This target could be increased to 30% under the conditions set out by the European Council of December 2009.

Therefore, the EU and its Member States wish to inform about these commitments in the format set out by Appendix 1 to the Copenhagen Accord:


* Currently, not all EU Member States are Annex I Parties.

** As part of a global and comprehensive agreement for the period beyond 2012, the EU reiterates its conditional offer to move to a 30% reduction by 2020 compared to 1990 levels, provided that other developed countries commit themselves to comparable emission reductions and that developing countries contribute adequately according to their responsibilities and respective capabilities.

The EU and its 27 Member States wish to recall that the EU Climate and Energy Legislative Package **has** already been adopted¹. Among other things, this Package consolidates the EU's Emissions Trading Scheme and expands its scope. Also, pursuant to its 'Effort Sharing Decision', Member States are required to implement policies and measures that **are** additional to that Scheme concerning **the** greenhouse gas **emissions** from sources not falling under it, in order to reach the overall target.


We would be grateful if the Secretariat would communicate this letter to the other Contracting Parties.

¹ Decision n° 406/2009/EC of the European Parliament and of the Council of 23 April 2009 on the effort of Member States to reduce their greenhouse gas emissions to meet the Community's **greenhouse** gas emission reduction commitments up to 2020 and Directive 2003/87/EC of the European Parliament and of the Council of 13 October 2003 establishing a scheme for **greenhouse** gas emission allowance trading within the Community and amending Council Directive 96/61/EC, as amended by Directive 2009/29/EC of the European Parliament and of the Council of 23 April 2009, amending Directive 2003/87/EC so as to improve and extend the greenhouse gas emission allowance trading scheme of the Community.
