1. THE PRIMARY RESPONSIBILITY FOR DETERMINING POLICY TO BE OBSERVED IN RESPECT OF PERSONS WHO KNOWINGLY MAKE FALSE DENUNCIATIONS WITH INTEND TO HARM SHOULD BE CONSIDERED AS RESTING WITH CONGOLESE AUTHORITIES. AS REGARDS THE ROLE OF ONUC IN THIS CONTEXT, WE ARE PREPARED TO PROVIDE CONGOLESE WITH THE PERTINENT INFORMATION WE MAY HAVE AND ASSIST IN THE FORMULATION AND CARRYING OUT OF THEIR POLICY.
2. EYE APPRECIATE FORCE OF PALMAGNE'S POSITION PROPOSING PROSECUTION OF FALSE DENUNCIATORS AS THEIR ACTIONS TEND TO UNDERMINE PUBLIC SENSE OF SECURITY. ON OTHER HAND, WE HAVE STRONG INTEREST IN AVOIDING DISCOURAGEMENT OF BONA FIDE REPORTS BY PRIVATE PERSONS REGARDING CONCEALMENT OF ARMS OF FORMER GENDARMES. J'ai l'honneur d'accuser réception de votre lettre N° 532/63/GAB/PM du 9 mars 1963 concernant la réinstallation de l'ANC au Sud-Katanga.

Comme vous avez bien voulu le souligner, l'ONU a toujours reconnu la nécessité de réinstaller l'ANC au Sud-Katanga. C'est en raison de la tension qui existe encore dans cette province et de l'hostilité de certains éléments de la population envers l'ANC que l'ONU a cru nécessaire d'insister sur une implantation échelonnée, contrôlée et soigneusement préparée. Il y a eu récemment, comme vous le savez, quelques incidents regrettables à Elisabethville dans lesquels des éléments de l'ANC ont été impliqués.
