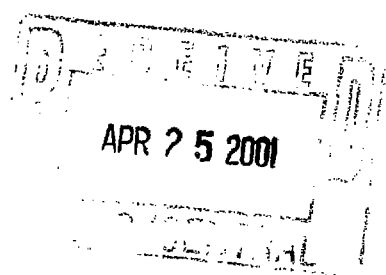

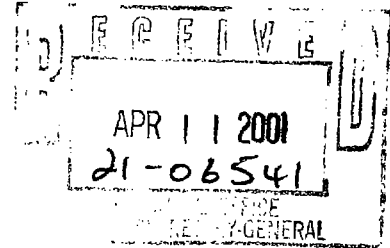

**Subject:** Representation of the Secretary-General at the Golden Spear 01 Senior Level Symposium

1. Thank you for your fax message of 5 April 2001 conveying the Secretary-General's request that the High Commissioner represent him at the Golden Spear 01 Senior-Level Symposium, to be held in Kenya on 24 July 2001. The High Commissioner, who is on mission in Ethiopia, has asked me to reply on his behalf.

2. The High Commissioner would prefer to decline the request, due to another important engagement foreseen for the same date. In addition, the High Commissioner expects to travel to Lusaka for the OAU Summit on 9-10 July, making it difficult for him to undertake another trip to Africa so soon afterward.

3. The High Commissioner hopes that the Secretary-General would appreciate these considerations. As an alternative, he would propose that Ms. Mary Ann Wyrsh, the Deputy High Commissioner, attend on his behalf. Please let us know whether this would be agreeable to the Secretary-General.
