Subject Heads up -- meeting request from a Parliamentarian in Japan

Mr. Yoon --

Ms. Miyoshi will hand deliver an invitation from a Parliamentarian in Japan working on Myanmar.--- but long story short -- they want EOSG to decline it.

The Background info from the Mission came as follows:

There are four Parliamentarians' League related to Myanmar: PL for Supporting Democratization of Myanmar (Chair: Tadamori Ohshima), Japan-Myanmar Friendship PL (Chair: Hideomi Watanabe), PL for Promoting Exchange between Japan and Myanmar (Chair: Makoto Koga), and PL for Promoting Assistance to the Government of Myanmar (Chair: Kabun Mutoh).

As the request was made only by one of them, the MOFA feels SG should not feel obligated to meet with them as the schedule is already tight. It could also invite unnecessary noise from other PLs.

Therefore MOFA believes it would be appropriate if SG's office conveyed regret for not being able to accommodate their request due to SG's tight schedule in Tokyo.

Mr. Tadamori Ohmori did not insist on his request knowing SG's already tight schedule.
