IN GEORGES ABSENCE EYE OPENED YOUR EV 749 AND FULLY SHARE
YOUR VIEWS THEREIN EXPRESSED. AFTER DISCUSSION PROBLEMS HERE WE
BELIEVE OPERATION MUST GO SLOWLY TO ENSURE MINIMUM LOSS OF LIFE.
THIS IS NOT A NORMAL MILITARY OPERATION IN THAT GREAT CARE MUST BE
TAKEN TO ENSURE THE VERY MINIMUM DAMAGE TO CIV LIFE AND PROPERTY
WHICH WOULD OTHERWISE NOT BE SO IMPORTANT. OPERATION COMPLICATED
BY CIV SNIPING PROBLEM, DISCUSSED IN MY 277, BELIEVE EVILLE MIGHT
CONTROLLED WITHIN 5 DAYS TO ONE WEEK AND REST OF SOUTH KATANGA
IN 2 WEEKS, GIVEN NECESSARY REINFORCEMENTS. A MAJOR FACTOR IS
ANXIETY OF WHITE POPULATION CONCERNING CENTRAL GOVT ANC ENTRY. OUR
EFFORTS TO SWING THEM WILL HINGE LARGELY ON POSSIBILITY OF ASSURANCE
THAT ALBERTVILLE EXPERIENCE WILL NOT BE REPEATED. THEIR INTERESTS
ARE PREDOMINANTLY VEN^UAL AND SO ALSO NECESSARY TO ASSURE THEM THEIR

IN VIEW FAILURE OF OUR EFFORTS AT NEGOTIATED SOLUTION FOR

SEQUENCE OF EVENTS. MADE CLEAR THAT FOR 1 WEEK WE HAVE SHOWN UTMOST

SPOKE TO KIMBA AT 11.30 AFTER CABINET MEETING. HE WAS IN THE MEETING OF GENERAL STAFF. EYE INFORMED HIM THAT WE HAD TRIED FOR 2 DAYS CONCILIATION TO SOLVE OUR DIFFICULTIES BUT WITHOUT SUCCESS. WE FEEL OUR GOOD FAITH HAS BEEN ABUSED BY PRESENCE OF TROUBLEMAKERS SINCE HIS ORDER TO LIFT ROADBLOCK WE ARE INFORMED HIS GENDARMERIE ARE MOVING UP TO ENCIRCLE AIRPORT AND DORNIER FLEW OVER AT 10.30. EYE SAID WE HAD LITTLE DOUBT THIS WAS A CONCERTED PLAN DOUBTLESS ALSO UNKNOWN TO HIM. HE COUNTERED WITH SOME VERY FEEBLE CHARGES AGAINST US WHICH EYE ISMISSED. HE THEN BEGGED ME TO CONTINUE CONVERSATIONS AND TO RESTRAIN OUR MILITARY WHILE HE WOULD DO SAME WITH GENDARMERIE. EYE SAID MATTER THAT WAS NOW OUT OF OUR HANDS/FOR NORMAL REASONS WE HAD NOW TO ASSURE FREEDOM OF MOVEMENT AND THAT RESPONSIBILITY FOR WHAT MIGHT HAPPEN WAS HIS. 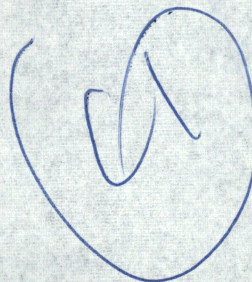
