### THE SITUATION IN ANGOLA

Financial implications of the draft resolution contained  
in document A/L.420

Report by the Secretary-General

1. Operative paragraph 1 of the draft resolution contained in document A/L.420 requests the President of the seventeenth session of the General Assembly to appoint two United Nations Representatives, one for the purpose of gathering information on conditions in Angola, the other for the purpose of gathering information on conditions in Mozambique (in both cases including information on political, economic and social conditions) by visiting those two territories and other places as they may deem necessary. Operative paragraph 3 of the draft resolution in question requests the United Nations Representatives to draw up reports for consideration by the General Assembly at its eighteenth session.
2. In accordance with rule 15<sup>4</sup> of the rules of procedure of the General Assembly, and in the event of the adoption of the resolution by the General Assembly, the Secretary-General would estimate that additional expenses of the order of \$64,000 would arise as follows:

	\$
(a) Salaries, allowances and other common staff costs for the two United Nations Representatives for a period of approximately six months	32,500
(b) Travel and subsistence costs for the two United Nations Representatives, assuming one return trip from Headquarters to Africa and incidental travel in the field	11,600

	\$
(c) Travel and subsistence of supporting staff comprising two first officers and two secretaries	19,200
(d) Miscellaneous expenditure for communications and other general expenses	<u>700</u>
	<u>64,000</u>

Accordingly, the Secretary-General would request additional credits in the amount of \$64,000 under section 18 of the 1963 budget estimates.

THE SITUATION IN ANGOLA

United States of America: draft resolution

The General Assembly,

Recalling its previous consideration of Angola and of Mozambique,

Having concluded that there is a need for further detailed information from within Angola and Mozambique on conditions there,

1. Requests the President of the seventeenth session of the General Assembly to appoint two United Nations Representatives, one for the purpose of gathering information on conditions in Angola, the other for the purpose of gathering information on conditions in Mozambique (in both cases including information on political, economic and social conditions) by visiting those two territories and other places as they may deem necessary;

2. Requests the Government of Portugal to extend to the United Nations Representatives such assistance as they may require pursuant to their mandate;

3. Requests the United Nations Representatives to draw up reports for the consideration of the General Assembly at its eighteenth session.
