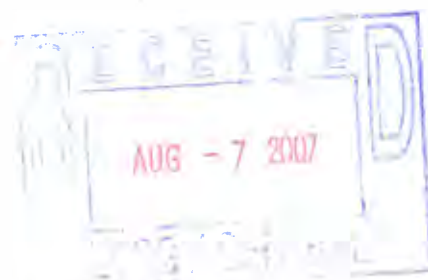
I have also taken note that Mr. Saeed Rashed Al-Hebsi, Second Secretary, will be acting as Chargé d'Affaires a.i..

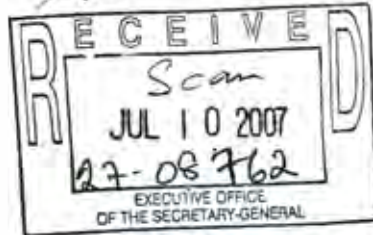

Excellency,

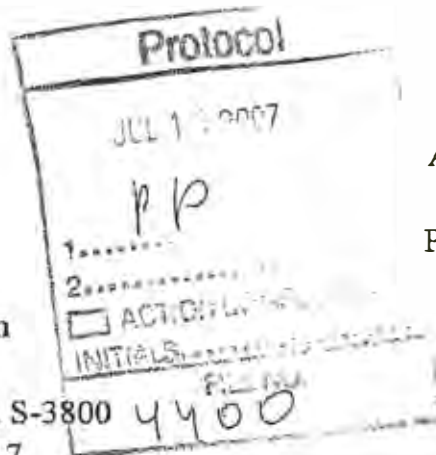
I have the honour to inform you that I shall be relinquishing my post as Permanent Representative of the United Arab Emirates to the United Nations, effective as of 14 July, 2007.


I would like to take this opportunity to express my deep appreciation for the kind support which you and your office have extended to me and the UAE Mission during my six years of tenure here.
