OUR CHIEF COMMUNICATIONS OFFICER HAS ADVISED AGAINST PASSING CONGOLESE OFFICIAL MESSAGES IN CYPHER VIA OUR TELECOMMUNICATION FACILITIES BECAUSE HE CONSIDERS THIS MAY ENDANGER OUR ENTIRE INTERNAL CODE SYSTEM. WHILE IT IS ADMITTEDLY DESIRABLE TO ASSIST CONGOLESE AUTHORITIES OCCASIONALLY IN TRANSMISSION OF URGENT MESSAGES, I CANNOT DISREGARD ABOVE ADVICE AND THEREFORE HAVE DECIDED THAT WE SHOULD HENCEFORTH DISCONTINUE THIS ASSISTANCE. HOWEVER, EXCEPTIONS WILL BE MADE IN CASES WHERE TRANSMISSION IS CONSIDERED VITAL FOR MAINTENANCE LAW AND ORDER. IN THESE CASES MESSAGES SHOULD BE INCORPORATED IN CABLES IN INDIRECT SPEECH.


