

OF UNAMIR GHANBATT 3 FROM AREA
OF OPERATION TO GHANA

GENERAL

1. As part of the drawdown on UNAMIR Operations, there is to be a reduction in strength of GHANBATT 3 from 295 to 135 All Ranks by 28 Jan 96.

MISSION

2. To repatriate 151 All Ranks of GHANBATT 3 from the AO to Accra, Ghana on 28 Jan 96.

EXECUTION

 - (1) Phase 1. Mov of pers by road from GHANBATT HQ, Kibungo to Conc Area at UNAMIR Transit Camp, Kigali.
 - (2) Phase 2. Repatriation of pers to Accra, Ghana.
 - (3) Phase 3. Dispersal of pers from EL-WAK Stadium to their various units.

(3) Route. Kibungo - Rwamagana - Kigali.

(4) Speed Limit. 60 Km/Hr.

(5) Flight/Mov Plan. By air, B727 Aircraft Charter Flight - Kanombe International Airport, Kigali - Kotoka International Airport, Accra.

(6) Flight Manifest. Chalk List attached as Annex A.

(7) Flight Arrangements. GHQ(IPKOP), ARMY HQ (OPS), DST, MCC (UNAMIR) and UEO GH3 are responsible for the flight arrangements.

(b) Hand Luggage. Hand luggage will be inspected on D-Day before pers board the aircraft.

(10) Contraband Items. List of Contraband items is at Annex B.

(11) Weight Limitation. Each pers is allowed 45 Kg. Pers to comply strictly with the weight limitation.

(12) Handing Over of Military Kit/Eqpt. Troops will handover their military kit/eqpt to the QM on D-2 at the UNAMIR Transit Camp.




