You will recall that recently we addressed a telegram to you stating that the man of the above name whose extradition has been requested by POLAND does not appear to be identical with the man of the same name listed by you in List No. 10, No. 463.

The 'BARTSCH' held in custody pending his extradition to POLAND is alleged to have been adjutant to the SS Polizeiführer in Krakow and to have been responsible for the deportation, torture and murder of Jews in Krakow between 1939 and 1944. He admits having been in Krakow. It would appear therefore that he cannot possibly be identical with the man in your list. Further, the Polish Authorities state that they made application for his listing in December 1946 whereas your List No. 10 is published in 1945.

It would be appreciated if you would inform this Office whether you received an application for the listing of the 'BARTSCH' alleged to have been in Krakow and whether you refused such listing. He is due to appear before the Extradition Tribunal in HAMBURG again on 26 April '48 and your reply, if necessary by telegram, before that date will be much appreciated.
