EYE HAD A MEETING WITH TSHOMBE FROM 9 TO 1130 THIS MORNING.
EYE REQUESTED HIM TO GIVE FIRM ORDERS TO THE KATANGESE

TAKEN THEN. HE GAVE ME THE IMPRESSION THAT HE WOULD ESTABLISH A PROGRAMME ALONG THE FOLLOWING LINES

- (A) CEASE FIRE AND STOPPAGE OF TROOP MOVEMENTS.
- (B) ACCEPTANCE OF A TRIPARTITE OBSERVATION GROUP IN KEY PLACES.
- (C) EXAMINATION OF A PLAN FOR INTEGRATION OF THE GENDARMERIE.
- (D) THE OATH OF ALLEGIANCE BY SENIOR OFFICERS.

I TOLD HIM THAT EYE WOULD BE BACK ON THURSDAY THE 12TH OF OCTOBER TO CHEK ON PROGRESS MADE IN TAKING THESE STEPS.

IN CONNECTION WITH THE REVENUE AND FOREIGN EXCHANGE COMMISSIONS, EYE REQUESTED TSHOMBE TO GIVE ORDERS TO HIS DELEGATION TO SUBMIT FIGURES, MAKE AVAILABLE BOOKS FOR EXAMINATION AND AGREE ON ADMINISTRATIVE METHODS. HE EXPRESSED SURPRISE THAT FIGURES AND BOOKS HAD NOT BEEN MADE AVAILABLE TO THE COMMISSION, AND ASSURED ME THAT INSTRUCTIONS WOULD BE GIVEN IMMEDIATELY. HE COMPLAINED THAT THE DRAFT CONSTITUTION HAD NOT BEEN MADE AVAILABLE TO KATANGA, AND SUGGESTED THAT UNITED NATIONS MAKE SERVICES OF AN EXPERT AVAILABLE TO KATANGA, PREFERABLY HIS FORMER FRIEND STAVROPOULOS TO HELP THEM STUDY THE DRAFT CONSTITUTION WHEN IT IS MADE AVAILABLE TO THEM BY THE CENTRAL GOVERNMENT. EYE REMARKED THAT THE SENDING OF AN EXPERT TO THEM WILL HAVE TO BE UNDER THE SAME CONDITIONS AS IN JANUARY. HE EXPRESSED FEARS THAT AN AMNESTY DRAWN UP BY THE CENTRAL GOVERNMENT MAY NOT MEET THE REAL

NEEDS OF KATANGA. EYE REQUESTED HIM TO PUT HIS IDEAS ON PAPER AND IF POSSIBLE MAKE AVAILABLE TO ME A DRAFT ON AN AMNESTY DECREE SO THAT HE COULD BEGIN TO THROW OUT FEELERS TO FIND OUT POSSIBLE POINTS OF COMPROMISE. EYE THEN REMINDED TSHOMBE THAT SECESSION MUST END

(A) AS A RESULT OF COOPERATION BETWEEN CONGO AND KATANGA WITH THE ASSISTANCE OF THE UNITED NATIONS, OR ELSE LESS FAVOURABLY AS A RESULT OF COOPERATION BETWEEN THE CONGO AND ANY NEW ALLIES CONGO MAY FIND IF THE UNITED NATIONS EVER DECIDES TO WITHDRAW FROM THE CONGO. EYE ADDED THAT THE POSSIBLE WITHDRAWAL OF ONUC FROM THE CONGO SHOULD NOT BE SO EASILY TAKEN FOR GRANTED BECAUSE MONEY IS A MEANS, VERY IMPORTANT ONE, BUT THE WORLD WILL HESITATE TO PLUNGE AFRICA AND MANY OTHER CONTINENTS INTO CHAOS BECAUSE OF THE FEW PENCE NEEDED TO PUT AN END TO KATANGES SECESSION.
