SECRET. CIV412 ABBAS FROM TICKNER. WE HAVE HAD ANOTHER INCIDENT IN
STAN. THE EUROPEAN STAFF OF THE TOBACCO COMPANY INCLUDING THE 2
ARRESTED AND RELEASED YESTERDAY MORNING GAVE A BARBECUE PARTY IN
THE EVENING AT THE COMPANY HOUSE IN THE FACTORY COMPOUND WHICH IS
NEAR TO CAMP KETELE. THERE WERE PRESENT 4 ENGLISHMEN AND 1 NIGERIAN
FROM THE COMPANY, AN ENGLISHMAN FROM THE CREDIT CONGOLAIS, 1 DUTCHMAN,
1 GERMAN AND 8 OF THE CANADIAN SIGNAL CORPS. AT ABOUT 2200 HOURS
THEY WERE ARRESTED AND TAKEN TO CAMP LEOPOLD BY MILITARY POLICE
EXCEPT FOR 2 SIGNALMEN IN UNIFORM. THEY WERE ALLOWED TO GO AND
IMMEDIATELY INFORMED ME AT MY HOTEL. WE NEGOTIATED WITH GENERAL
LUNDULLA FOR THE RELEASE OF THE CANADIANS 2 HOURS LATER AND FOR THE
RELEASE OF THE OTHERS QUOTE DEMAIN MATIN UNQUOTE. THEY WERE ALL
ILL TREATED INCLUDING THE CANADIANS. ALL BUT 1 WERE RELEASED ABOUT
0800 HOURS THIS MORNING EXCEPT 1 WHO WAS CARRYING A LARGE SUM OF
MONEY. HE WAS DETAINED UNTIL NOON BUT WAS NOT MOLESTED DURING THE
MORNING. THE ETHIOPIAN BRIGADE PARTICULARLY COLONEL TESHOME ASSISTED
US IN NEGOTIATIONS. THE ENGLISHMEN AND THE NIGERIAN CAME TO OUR
OFFICE WHERE THEY ARE AT PRESENT. GENERAL LUNDULLA CALLED ON ME AT
NOON AND ALTHOUGH HE OFFERED NO APOLOGIES HE WAS EMBARRASSED AT WHAT

HAD TAKEN PLACE. WE REMAINED ON FRIENDLY TERMS THROUGH THE INTERVIEW AND I THANKED HIM FOR HIS INTERVENTION. THE STORY AMONGST THE SOLDIERS IS THAT THE COMPANY HAS NEGOTIATED WITH THE PROVINCIAL GOVERNMENT TO TAKE SOME UNNECESSARY MACHINES TO LEO BUT IF THEY GO IT WILL DEPRIVE ORIENTAL PROVINCE OF SOMETHING WHICH MUST REMAIN HERE AND MUST NOT BENEFIT LEO THE GENERAL ACCEPTS THIS EMPHATICALLY IN ORDER TO SUPPORT THE ACTION OF HIS SOLDIERS. IT IS TRUE THAT THE REMOVAL OF MACHINERY HAS BEEN NEGOTIATED. THE ENGLISHMEN AND THE NIGERIAN ALL STATE THAT THEY MUST LEAVE STAN WHATEVER THE EFFECT OF THE CLOSING OF THE BANK AND THE FACTORY MAY HAVE ON THE PROVINCE AND THEIR COMPANIES. CAPTAIN STUBBS OF THE CANADIAN SIGNALS MADE AN ATTEMPT TO GET THE OTHER MEN RELEASED AT 0600 HOURS BY GOING ALONE TO THE CAMP. BUT AS ALREADY EXPLAINED GENERAL LUNDULLA HELD THEM AS LONG AS HE HAD STIPULATED TO US. I AM URGING PERSONNEL TO EXERCISE RESTRAINT IN THEIR MOVEMENTS. TO PUT THE MATTER IN FULL PERSPECTIVE, I SHOULD EXPLAIN THAT MILITARY POLICE HAVE BEEN ALERTED TO LOOK FOR A BELGIAN SPY OF MOBUTU WHO HAS PLENTY OF MONEY WITH HIM. YESTERDAY AFTERNOON A FRENCH JOURNALIST WITH 400 DOLLARS IN SWISS AND CONGOLESE FRANS WAS BRIEFLY DETAINED AND AS EXPLAINED ABOVE THE I ENGLISHMAN WITH MONEY WAS THE I DETAINED LONGEST THIS MORNING.

SECRET. CIV410 ABBAS FROM TICKNER. I HAVE 2 COPIES OF AN IDENTICAL LETTER SIGNED BY GIZENGA ADDRESSED TO THE PRESIDENT OF THE GENERAL ASSEMBLY AND THE PRESIDENT OF THE SECURITY COUNCIL AS FOLLOWS:

"MESSIEURS LES PRESIDENTS, J'AI D'HONNEUR DE VOUS FAIRE SAVOIR QUE LE PROBLEME DE MON PAYS, LA REPUBLIQUE DU CONGO, EST ENTRE DANS UNE PHASE DECISIVE DE L'HISTOIRE DE L'HUMANITE TOTE ENTIERE. SECRET. CIV409 ABBAS FROM TICKNER. THIS MORNING WE HAD AN UNSAVOURY INCIDENT 2 ENGLISHMEN, PRICE MANAGER OF THE CCT TOBACCO FACTORY AND AHSURST HIS CHIEF FROM LEO WERE ARRESTED OUTSIDE OUR OFFICE. THEY HAD JUST VISITED ME TO SAY THAT AFTER ENCOURAGING TALKS WITH LUNDULLA AND WITH MINISTERS THEY WERE HOPING TO GET IN THIS YEARS CROP NEXT AUGUST AND RUN THEIR PLANT TO FULL CAPACITY. AFTER ARREST THEY WERE TAKEN TO THEIR FACTORY WHICH HAD ALREADY BEEN OCCUPIED BY THE GENDARMERIE. WE INFORMED LUNDULLA AT ONCE BY TELEPHONE. THEY SUFFERED NO MORE INDIGNITY THAN BEING MADE TO SIT ON THE GROUND AND LISTEN TO ABUSE. THE FACTORY MANAGER WAS BADLY TREATED BUT THE FACTORY STAFF PREVENTED THE GENDARMERIE FROM TAKING HIM AWAY. HALF AN HOUR LATER 2 PROVINCIAL MINISTERS ARRIVED AND AFTER LOOKING INSIDE THE FACTORY MADE THE EXCUSE THAT THEY WERE SATISFIED THAT THE STATEMENTS WHICH WERE MADE YESTERDAY PRICE AND ASHURST WERE CORRECT AND THAT THEY COULD GO FREE. MEANWHILE THE CHIEF OF STAFF OF LUNDULLA APPEARED AND INTERVENED ON THEIR BEHALF. HIS ESCORT THEN ARRESTED 3 OF THE GENDARMES TO BE PUNISHED FOR ARBITRARY ARREST. THIS IS A WELCOME SIGN OF PEACE. WE UNDERSTAND THE REASON FOR THE ARREST WAS FALSE INFORMATION GIVE BY AN INFORMER.

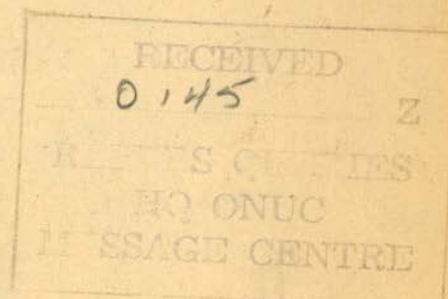

SECRET CIV401. ABBAS FROM TICKNER. THE FOLLOWING IS MY CONSIDERED JUDGEMENT ON THE QUESTION OF THE "PEACE TREATY" AND THE MILITARY PARADE. I NOW ACCEPT THE EXPLANATION THAT THE PARADE WAS FOR THE REASONS GIVEN TO ME NAMELY TO SHOW THE DISCIPLINE OF THE TROOPS AND TO ESTABLISH BETTER RELATION WITH THE CIVILIAN POPULATION. IT IS LIKELY THAT SOME DISCUSSIONS FOR A CEASE FIRE HAVE TAKEN PLACE BUT THE ONLY INDICATIONS OF THIS ARE SCRAPS OF INFORMATION LIKE THOSE WHICH I HAVE ALREADY GIVEN. IT HAS BROUGHT THE QUESTION OF AN ACCOMMODATION BETWEEN LEO AND STAN INTO WIDER PERSPECTIVE THAN A CEASE FIRE BETWEEN THE ARMIES. 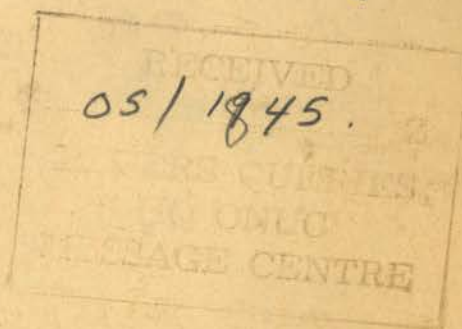

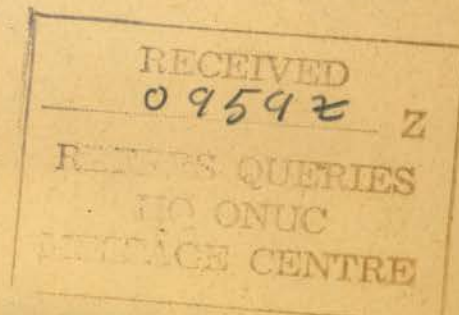
