IN THE MORNING OF THE 26 APR 1995 I WENT TO THE CELLULE KARANDAGYI, SECTOR MUDENDO, COMMUNE MUTURA. HERE I MET MR RUTAYISIRE MUSHUMBA, 45 YEARS OLD, LIVING IN THE SAME CELLULE.

AFTER THE STATEMENTS OF THE WITNESSES IS MR MUSHUMBA THE BROTHER OF THAT RPA-SOLDIER, WHO HAD ARRESTED MR SEBAHUTY AT THE EVENING OF THE 25 FEB 95. THIS SOLDIER MUST BE SUSPECT TO BE THE PERPETRATOR.

MR MUSHUMBA TOLD ME THE NAMES OF TWO OF HIS BROTHERS, WHICH ARE BOTH IN THE ARMY. THE FIRST ONE IS NAMED 'GAHENE'. WITH HIM HE HAS ONLY THE SAME FATHER. HE COULD NOT GIVE ME MORE OF THE PERSONAL DATA.

THE SECOND BROTHER, WHO IS BY THE ARMY, IS NAMED

APOLLINAIRE NDAYISABA, HE IS 20 YEARS OLD. WITH HIM HE HAS THE SAME FATHER AND THE SAME MOTHER. HE DOES NOT KNOW, WHERE HE IS LIVING AND TO WHICH RPA BRIGADE HE BELONGS.
