Excellency,






Excellency,

I would like to express my sincere gratitude for the warm reception and hospitality accorded to me and my delegation by yourself and the Palestinian Authority. I would also like to thank you for hosting a lunch reception in my honour on 20 March 2010 in Ramallah, as well as for your very kind gift.

I welcome the opportunity to hold a constructive discussion with you and other ministers involved in the state-building agenda on a broad range of issues. We will continue to support your highly commendable efforts to build the institutions of a viable Palestinian State. Of particular interest was my visit to the Masyoun lookout point where I witnessed many of the challenges and dilemmas you face.

Upon my return to New York, I briefed the Security Council. I stressed that there is no alternative to negotiations for a comprehensive and just resolution of the conflict and an end to the occupation that began in 1967. I highlighted the efforts and achievements of the Palestinian Authority, particularly in the area of security. I also emphasized that the situation on the ground had crucial implications for the peace process and that the international community must continue to support the resumption of negotiations and the creation of an environment conducive to the success of these negotiations.

Dear Mr. Grandi,

I would like to thank you and your staff for facilitating my visit to Gaza on 21 March 2010. I appreciated the opportunity to witness first-hand again the situation on the ground, and also to mark our recent modest step forward in Khan Younis, Tel el Sultan and El Bader, despite a difficult operational environment.

My meeting with representatives of civil society in Gaza allowed me to see the challenges they face, as they try to rebuild and preserve what is left of their life. Their determination has reinforced my own resolve to ensure that the United Nations does everything it can to help the civilian population of Gaza, and indeed the Palestinian people as a whole.

I will continue to call on Israel to take further meaningful steps to end the blockade, open the crossings and facilitate reconstruction and economic activity. I will also work to seek political solutions and the implementation of Security Council resolutions and international law.

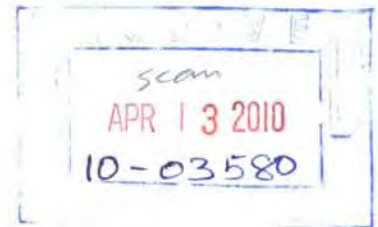


