1. I WENT WITH MATHU AND SHERRY TO SEE ILEO TODAY. MIN APPEARED MUCH CONCERNED AT ADOULAS FAILURE TO SUPPORT HIS VIEWS REGARDING DECENTRALIZATION OF FOREIGN EXCHANGE LICENSING, AND SIMILAR ECONOMIC MATTERS. HE FELT THAT ATTITUDE TAKEN IN LEO WAS AT VARIANCE BOTH WITH LOI FONDAMENTALE AND SECGENS PLAN, I PROMISED TO TAKE UP THE QUESTION WITH THE PRIME MINISTER URGENTLY AND TO INFORM HIM RIGHT AWAY

2. OTHER PROBLEM. WHICH WORRIES ILEO IS THAT OF GENDARMES STILL IN THE BUSH. DESPITE MUKES EFFORTS, NO MORE THAN 1500 ORS HAVE REGISTERED SO FAR. THERE IS NO INFO AS TO WHEREABOUTS OF THEIR WEAPONS AND HEAVY EQPT. 4. THE RECENT INCIDENTS IN ELI I HAVE STATED WERE THE BIGGEST SET-BACK IN JOINT EFFORTS TO INTRODUCE ANC HERE. SIMILARLY IF INCIDENTS OCCURRED AS CONSEQUENCE OF ANC TAKE-OVER AT SAKANIA RESULTS WOULD BE UNFORTUNATE. IT WAS ESSENTIAL TO STRENGTHEN CONSIDERABLY THE COMMAND SET-UP OF ANC UNITS SINCE 2 OFFRS COULD NOT RUN A BN ALONE

5. AS FOR DELAYS IN OBTAINING GENDARM INTEGRATION INSTRS OR OTHER INSTRS FROM LEO, I SUGGESTED THAT THE PROGRAMME BE DRAWN UP IN CONSULTATION WITH ONUC IN ELI AND SUBMITTED TO THE CENT GOVT. IT SHOULD THEN BE CARRIED OUT UNLESS CONTRARY INSTRS RECEIVED FROM ADOULA. IT MIGHT BE POSSIBLE SPEEDILY TO COMMENCE INTEGRATION ROUND NUCLEI AT JADOTVILLE AND KOLWEZI AS PREVIOUSLY DISCUSSED. TAKE ACCOUNT OF REMOTE AS WELL AS IMMEDIATE CONSEQUENCES OF ACTIONS. ILEO MADE CLEAR THAT HE HAD NO COMPLAINT AS TO UN COOPERATION

7. HE WANTED TO KNOW WHETHER ONUC HAD REJECTED HIS PROPOSALS ON RETAINING UN TPS AT MOKAMBO. IT WAS EXPLAINED TO HIM THAT LATEST PLAN FOR THE AREA HAD BEEN AGREED UPON FULLY BY ANC AND ONUC OFFERS. I URGED THAT WEEKLY MEETINGS BETWEEN ONUC AND CENT GOVT CIVILIAN AND MILITARY TOP OFFICIAL GET ORGANISED IN ELI TO PLAN AND CARRY OUT OPERATIONS AND TROOP MOVEMENTS

8. ILEO STATED THAT IN VIEW OF GREAT DELAYS IN SECURING AN INSTRS FROM LEO HE INTENDED HENCEFORTH TO ACT ON HIS OWN WHEREEVER HE FELT SURE THAT HE REMAINED WITHIN LINES OF CENT GOVT POLICY. AS THIS SEEMED TO GO A BIT FAR IT WAS UNDERSTOOD. AFTER DISCUSSION, THAT SUCH ACTIONS AS WERE AGREED UPON BETWEEN ILEO AND ONUC WOULD BE CARRIED OUT AFTER INFORMING BUT NOT AWAITING CLEARANCE FROM CENT GOVT. AS TO OTHER PROPOSAL ACTIONS I COUNSELLED PATIENCE

9. CONCERNING PROPOSED ONUC MOVE TO DILOLO ILEO INFORMED THAT MATTER HAD BEEN TAKEN UP WITH KITENGE, PROV MIN OF PUBLIC WORKS AND THAT CONTRACTOR HAD BEEN LINED UP BUT THAT FUNDS WERE LACKING. HE HOPED TO SECURE THESE FROM LEO. I ADDED THAT PROV AUTH WHICH HAD MANAGED TO BLOW UP BRIDGES, MIGHT WELL DEFRAY REPAIR COSTS

10. IN CONCLUSION, ILEO AGAIN URGED SPEED IN BRINGING ANC TO SOUTH KAT. HE STATED THAT ANC BEHAVIOUR TOWARD CONGOLESE AND FOREIGN POPULATION IN OTHER PROVINCES WAS NOW GOOD. RECENT INCIDENTS HERE, HE NOTED, HAD BEEN CAUSED BY FRESHLY ARRIVED TPS; HENCE THE DESIRABILITY OF HAVING ADEQUATE ANC STRENGTH HERE CONSISTING OF TPS ACCUSTOMED TO KAT CONDITIONS, WHEN ONUC FORCES ARE WITHDRAWN
