1. THE NEXT LOG CONFERENCE WILL BE HELD ON TUESDAY 7 FEB 95.
2. THE PURPOSE OF THE CONFERENCE IS, IN ADDITION TO THE NORMAL FORTNIGHTLY MEETING, TO INTRODUCE ALL LOGISTIC OFFICERS TO THE 2ND LINE SUPPORT AGENCY, 95 FLSG, AND ITS ROLE, TASKS AND CAPABILITIES. LOG OFFICERS WILL BE TAKEN ON A TOUR OF THE 2ND LINE FACILITIES AT THE TRAFIPRO COMPLEX, AND WILL BE BRIEFED ON HOW THE INTEGRATED SUPPORT SYSTEM AND THE REVISED PROCEDURES FOR SUPPLIES DEMANDS, WHICH WILL BECOME EFFECTIVE FROM 0800 HOURS WEDNESDAY 8 FEB 95, WILL FUNCTION.

PURPOSE: To prepare, with the SRSG, for the upcoming OAU/UNHCR conference in Bujumbura 15-18 Feb 95

ITINERARY:

- 11 Feb
  - Arrive in Nairobi at 08:35 (Air France ?) from Paris
  - Hold meetings with local officials
- 12 Feb
  - Depart for Kigali on UNAMIR aircraft on morning flight with Mrs Barrillon-Pomés (2 x VIP paxs)
  - Mr Kouyaté meets with Rwandan officials to include Prime Minister and President of the Republic
- 13 Feb
  - preparations continue to include internal meetings with Force Commander and SRSG for upcoming meeting
  - Mr Kouyaté and assistant visit Op Retour and IDP Camps in either Sectors 3 or 4A
- 14 Feb
  - Mr Kouyaté and Mrs Barrillon-Pomés depart Kigali for Bujumbura on UNAMIR aircraft (either fixed-wing or rotary-wing)

SUPPORT REQUIREMENTS

ACCOMMODATION: 1 X VIP Suite at BBC (Mr Kouyaté) and 1 X room at Hotel Mille Colines.

AIR TRANSPORT: 2 X VIP seats on UNAMIR Aircraft NBO - KGL on 12 Feb and either fixed or rotary-wing transport to Bujumbura on morning 14 Feb.

GROUND TPT: 1 X VIP STAFF CAR WITH DRIVER DURING PERIOD 12 - 14 FEB. May be possible to have assist of SRSG security personnel.

MEETINGS: Joint meetings with SRSG, FC and DFC on 13 Feb. Meetings with Rwandan officials on 12 Feb.

SECRETARIAL: Mr Kouyaté and assistant will require a working area and some dedicated secretarial support to prepare for the upcoming conference. They may require the services of a translator as well.




