TSHOMBE'S LETTER (ELLEO 917) GIVES RISE TO THE FOLLOWING THOUGHTS WHICH OUR PEOPLE IN ELISABETHVILLE MAY USE IN DISCUSSING THIS MATTER WITH KATANGESE AUTHORITIES. IN ACCORDANCE WITH ONUC'S DECISION TO DISSOLVE REFUGEE CAMP, REFUGEES WILL HAVE TO BE SENT EITHER TO THEIR AREA OF ORIGIN OR ELSE SHOULD GO BACK TO THE COMMUNES IN ELISABETHVILLE UNDER ADEQUATE GUARANTEES AND PROTECTION FROM THE KATANGESE AUTHORITIES. TSHOMBE CANNOT HAVE IT BOTH WAYS, AND IF HE NOW FEELS UNHAPPY ABOUT THE RETURN OF NORTH KATANGA BALUBAS TO THE ALBERTVILLE AREA, HE SHOULD FACILITATE, BY WORDS AND BY DEEDS, THEIR SAFE RESETTLEMENT IN THE ELISABETHVILLE COMMUNES.
