## Instituto de la ONU funcionará en enero

El Instituto Latinoamericano de Defensa Social de las Naciones Unidas empezará a funcionar con sede en nuestro país a partir del primero de enero de 1975.

Aunque los documentos para suscribir el contrato fueron enviados hace algunas semanas a la Secretaría General de la ONU, desde hace varios meses viene funcionando una oficina en San José, a cargo del Lic. Jorge Arturo Montero Castro.

El licenciado Montero Castro, exministro de Gobernación y exdirector de Adaptación Social fue nominado por la ONU como Secretario del Instituto de Defensa Social para América Latina.

Este instituto desarrollará dentro de otras actividades, cursos de adiestramiento y preparación de personal encargado del manejo y tratamiento de internos en centros penitenciarios.

Los cursos serán impartidos por técnicos en la materia de varias nacionalidades, y contarán con financiación de las Naciones Unidas.

Como parte de esas actividades, nuestra capital será sede de un seminario de defensa social, con la participación de delegados de todos los países miembros de la ONU.

En ese cónclave, se elaborará y analizará el programa a realizar por el Instituto Latinoamericano de Defensa en los próximos tres años, y se tratará de lograr ante los respectivos gobiernos que la planificación de la defensa social se incluya en los programas de desarrollo de los países latinoamericanos.

A este seminario sobre defensa social asistirán los ministros de justicia y de planificación de todos los países latinoamericanos, ya que se trata de un cónclave de alto nivel.


Subject: Costa Rica - Country Programme Review,-

Dear Mr. Chang:

It has come to our knowledge that the Paraguayan Government has the intention of getting the United Nations technical assistance in Public Finance Administration through Mr. Barbosa Roca's service.

In order to coordinate our institutional activities in Latin America, I thought it would be useful to let you know that our Program is already providing to the Paraguayan Government technical assistance in the national budgeting system as well as in the implementation of the fiscal accounting law.

As far as operation is concerned it will be very difficult to separate the specific fields for each one of the technical assistance missions, the eventual mission of Mr. Barbosa Roca could result in overlapping.

Our expert in Paraguay, Mr. Angel Gorostiaga has been working with the Finance Ministry since February of 1974 and his mission has been recently extended for two more years at the request of the Paraguayan Government.

I would like to take this opportunity to send you a copy of the last report on our activities in Latin American countries.

I would very much appreciate to receive some information about your program in the same countries in order to obtain a better coordination of our activities.

I will be very glad to give you any further information that you may require.
