1. This sitrep covers the period from 2359 hrs, 29-3-95 to 30-3-95
2359 hrs

a. Operation Ralentir still in progress with the aim to minimise or reduce the alarming UNAMIR accident cases in the mission - Rwanda - Kigali.

b. At about 0830hrs, a team comprised of two (2) MPs escorted finance section to Kenya - Nairobi for certain financial transactions. The team returned at about 1600 hrs.

c. Between 1930hrs and 2030hrs on 28th March 1995 UNIS NE C537 of Brown and Root reported of missing Handset Radio Motorola GP 360 SRL NO 174 ID# 222 at Guest House Hotel - KIBUYE - Rwanda. However, investigation continues and report will be submitted.

d. At about 1725 hrs, there was a traffic accident at BLVD L'umunganda near MP Coy - Kigali - Rwanda involving UNAMIR 459 white Nissan Pick up driven by UNIDOR 7479 of MINUGS Air ops Kigali International Airport and a bull cow which suddenly crossed the mentioned vehicle and was hit, and it was pronounced dead instantly. Report to be submitted.

e. At about 1930 hrs, personnel from Human Rights visited this office with the aim to see the Rwandais Local under protective security.

f. UNAMIR MP Company continues to provide general security throughout the Kigali - Rwanda - by mobile patrols.

a. Report UNAMIR MP COY continued to provide security for the Rwandan locals and in the MP compound.

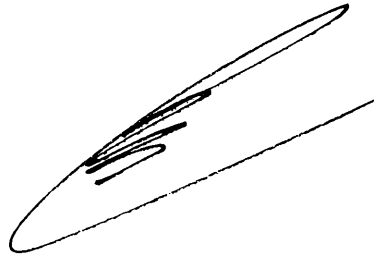

1. This sitrep covers the period from 2359 hrs 24-3-95 to 2359 hrs 25-3-95.
 - a. At about 1410 hrs, on 22nd March '95 there had been a traffic accident at MUKAMIRA AND KARAGO ROAD KIGALI - RWANDA - involving white Toyota 4x4, UNAMIR 1115 and 1985 white nissan sunny Registered no 432 UAK. Traffic Section - comprised of (3) three MPs despatched to scene, all the necessary information obtained - Report to be submitted.
 - b. At about 1220hrs, on 23 march '95 there was a traffic accident at MBAZI commune BUTARE - RWANDA - KIGALI involving BEDFORD TRUCK WHITE - UNAMIR no 3800 and white Toyota Hiace registered no BR 4212. PL team of (2) two MPs despatched to the scene of accident - Report to be submitted.

c. At about 2130 hrs, on 24 March '95 there was a theft of RADIO ANTENNAE from UNAMIR vehicle no- 1153 which was parked at NYAKABANDA - KIGALI - RWANDA. The case referred to Special Investigation Branch for which report will be submitted.

d At about 1110 hrs, the force Provost Marshal reported that UN ID NO 064 of FIELD SERVICE KIGALI - RWANDA travelling in UNAMIR vehicle no 1131 TOYOTA LAND CRUISER was stopped and detained at RPA check point outside KIGALI, and therefore needed MP assistance. A patrol team of (2) two MPs despatched and met the RPA authorities and the victim was released accordingly.

e. At about 1120 hrs, UN ID NO MO 7868 of MILOB Sector 3 GITARAMA went to KIGALI POST OFFICE to post his letters, in the process to open the entrance door which was made of glass got broken accidentally and he was held by RPA soldiers. (2) two patrol teams comprised of (4) four MPs despatched and negotiated with the RPA authorities, and the MILOB was released on condition to see the POST MASTER on MONDAY - 27 MARCH 95. Investigation continues, Report to be submitted.

1. This sitrep covers the period from 2359 hrs, 23-3-95 to 24-3-95 2359 hrs


a. At about 0815hrs UN MP COY Traffic Section dispatched two patrols to Ruhengeri area to conduct traffic regulations enforcement.

e. UNAMIR MP Coy is providing close protection service to a Rwandan at the UN MP Coy location.



SUBJECT: UNAMIR MP COY DAILY SITREP

1. This sitrep covers the period from 2359 hrs, 2 FEB 95 to 2359 hrs 3 FEB 95:

a. At 0000 hrs, 3 FEB 95 UNAMIR 4817 assigned to INBATT KIGALI - RWANDA and driven by LAXMAN WAPPA was hit by vehicle with Reg. NO CB 17.91 driven by EPIMAGUE KANYAMUGIRE of KEMERA - RWANDA who lost control on Boulevard de L'OUA L'AVENUE KIGALI. No injuries were sustained. Investigation still continues.

b. Reference the 3 Rwandan Civilians detained by UNAMIR MP Coy, it has been determined that the evidence obtained against them was insufficient to justify them being handed to the Civil authorities and were handed over to the NGO of Guern M BIZIMANA INNOCENT present at the location where detainees were arrested initially.

C. At 1355HRS 3 FEB 95, an unknown driver whose particulars are not yet known struck vehicle with Reg. No CS 27.27 assigned to UNTER driven by DOMINIQUE NATHAN of UNTER BURUNDIAN on road KIGALI-GITARAMA about 25 km from KIGALI. 24 people were injured. Investigation are continuing.

d. At 1210HRS 3 FEB 95, at CONGOLE-KIGALI UNAMUR 1700BR driven by GOODENOUGH LEO of IVECO KIGALI struck a bicyclist, whose particulars are not yet known, who was speeding without observing.

E. At 1640HRS 3 FEB 95, a driver of UNAMUR 4607 assigned to NICOLAS CAH IBRAHIM AUSTAFI lost control whilst travelling to UNAMUR HQ and fell on the right side of the road at a junction near Belgium Village. It was a self accident and no injuries were sustained. Investigation still continues.


F. Members of the force MP Company conducted OP REHABILITATION in the area of KIGALI. 11 traffic violation reports issued.

1. This sitrep covers the period from 2359 hrs, 31 Jan 95 to 2359 hrs 1 Feb 95:

- a. At 0830hrs, 1 Feb 95, Maj J-G Plante, CO force MP Coy opened the Force MP Company Training Academy located in the Transit Camp. 25 Military Police Persons (Senior non-Commission-officers) and one MP officer are attending a four day Seminar on MP Shift Commander duties and responsibilities. Additional MP Courses will begin next week.
Computer Courses related to DOS and Word perfect 5.2 are also been given to MP Coy Interpreters / Translators.
- b. At 1000hrs, 1 Feb 95 UN MP Coy was despatched to Investigate a minor accident involving UNAMIR vehicle and a cyclist which took place within REMERA KIGALI. Only Minor injuries and damage was sustained to the cyclist and the cycle. Report to be submitted by the duty shift.

SUBJECT: UNAMIR MP COY DAILY SITREP

1. This sitrep covers the period from 2359 hrs, 30 Jan 95 to 2359 hrs, 31 Jan 95:

- a. at 1000 hrs, 31 Jan 95 UN MP Coy was dispatched to investigate a minor accident, no injuries involving two UNAMIR Vehicles which took place within the UNAMIR HQ Parking Lot, Kigali, Rwanda. Only minor damage was sustained to both vehicles. Report to be submitted by the duty shift;
- b. at 1225 hrs, 31 Jan 95 UN MP Coy was detailed to investigate an accident involving a UNAMIR Vehicle and a pedestrian which occurred in central Kigali, Rwanda. The accident occurred on 27 Jan 95 but was not reported to this office until the a/m time, date. The Civilian pedestrian was taken to the Australian Hospital on 27 Jan 95, however the individual departed the Hospital on 28 Jan 95 without permission and has yet to return for treatment. Nil damage was sustained to the UNAMIR Vehicle;

- c. reports that traffic enforcement patrols were conducted by the Day Shift 31 Jan 95 and as a result six traffic violation reports were submitted for various traffic offenses;
- d. reports that UN MP Coy Invest Section are investigating an incident of an exchange of gun fire between Soldiers of the previous Government of Rwanda (RGF) and members of Ethiopia Batt. The incident occurred at 0300 hrs, 28 Jan 95, during a routine patrol in the area of KAVUNE (Sector 4C), Kigali, Rwanda. Two soldiers of the previous Government were injured one of which sustained serious injuries. One Soldier (bandit) was killed, as well as one civilian member of the Catholic Mission who died as a result of his home being robbed. One Ethiopia Soldier was slightly injured in the head area when one of the bandits threw a grenade in the direction of the patrol team. Investigation into this incident is continuing
- e. reports UN MP Coy are providing close protection services for one Rwandan National residing within UN MP Coy Compound; and
- f. reports UN MP Coy also conducted numerous routine traffic patrols throughout the Kigali area.
