IL PARAIT QU'ON PARLE SERIEUSEMENT DE L'ESTABLISSEMENT D'UN GOUVERNEMENT PROVINCIAL INDEPENDANT DE CELUI DE BUKAVU ET QUE KANGA IGNACE (NON PAS GANGA IGNACE COMME RAPPORTE AUPARAVANT) SERAIT DESIGNE PRESIDENT DU NOUVEAU GOUVERNEMENT PROVINCIAL

[HAVE HAD A LONG DISCUSSION WITH LUNDULLA. AS EXPECTED HE  
FLATLY REFUSED TO CONFRONT THE 6 SOLDIERS WITH PAKASSA. LUNDULLA  
CANNOT SEE ANY REASON WHY PAKASSA SHOULD SEE THE SOLDIERS AS  
PAKASSA WAS NOT AT KONGOLO WHEN MASSACRE TOOK PLACE. LUNDULLA  
GAVE THE FOLLOWING ACCOUNT OF THE MASSACRE, LIEUTENANT KASANGANAY  
WAS THE COMDR OF THE 6 ARRESTED SOLDIERS AND SERGEANT LISSO. WHEN  
THE MISSIONARIES WERE TAKEN OUT FROM THE PRISON KASANGANAY WAS  
CALLED AWAY FROM THE PRISON. DURING HIS ABSENCE THE MISSIONARIES  
WERE SHOT BY THE 6 SOLDIERS. LISSO WAS PRESENT AT THE MASSACRE.  
WHEN KASANGANAY CAME BACK THE MISSIONARIES WERE ALL DEAD. THE  
LOCAL COMMANDER MAJOR DABA APPREHENDED THE SOLDIERS AND ESTABLISHED  
A PROCES VERBAL THAT WAS PRESENTED TO LUNDULLA UPON HIS ARRIVAL.  
LUNDULLA ARRESTED THE SOLDIERS AND BROUGHT THEM TO STAN. LISSO  
ESCAPED. LUNDULLA STATED THAT MONSEIGNEUR KIBWE CAN CERTIFY HIS  
REPORT. HE FURTHER MENTIONED THAT THE WAR TRIBUNAL WILL INTERROGATE  
THE ALLEGED CULPRITS AND THAT A REPORT WILL BE SENT TO CENTRAL  
GOVERNMENT. KASANGANAY IS STILL IN STAN WHEREAS DABA HAS RETURNED  
TO KONGOLO. LISSO WAS FOUND IN KINDU AND IS NOW UNDER ARREST IN  
STAN. ACCORDING TO LUNDULLA IT HAS BEEN NOW ESTABLISHED THAT LISSO  
AND THE 6 SOLDIERS ARRESTED ARE THE CULPRITS AND HE THEREFORE  
CAN SEE NO REASON WHY PAKASSA SHOULD BE BROUGHT INTO THE PICTURE.  
FURTHERMORE LUNDULLA INSISTS ON SEEING ADOULA BEFORE PROCEEDING  
ANY FURTHER. IN VIEW OF ALL THIS AND ALSO OF HIS SEEMINGLY  
IN DIFFERENT AND EVASIVE ATTITUDE TO THE MASSACRE OF THE MISSIONARIES  
IT IS NOT SURPRISING THAT MY ATTEMPTS TO PERSUADE HIM WERE  
UNSUCCESSFUL. A CYNICAL ARTICLE IN UHURU OF FEB 3 ALSO REVEALS  
THE GENERAL FEELINGS HERE ABOUT THE SLAUGHTER OF THE MISSIONARIES.  
IF THE KONGOLO INQUIRY IS TO PROCEED ANY FURTHER IT SEEMS NECESSARY

[HAVE HAD A LONG DISCUSSION WITH LUNDULLA. STRUGGLED HARD WITH HIM FOR THE DEFINITE AND PROMPT SETTLEMENT OF THE KINDU AFFAIR. TOLD HIM THAT, AFTER LAGOS AND BEFORE NEW YORK, ADOULA IS OVERWHELMED WITH WORK AND THAT THE IMPORTANCE OF HIS MISSION TO NEW YORK MAKES IT NECESSARY TO PUT OTHER THINGS ASIDE FOR THE MOMENT. LUNDULLA AGREES THAT SOMETHING HAS GOT TO BE DONE ABOUT WATSA COMPANY. KNOWING THAT ADOULA RETURN TO LEO THIS WEEK HE INSISTED TO SEE ADOULA BEFORE TAKING ANY ACTION AND HE COULD NOT UNDERSTAND WHY THE MATTER COULD NOT WAIT A FEW DAYS MORE. THE REASON FOR LUNDULLAS RELUCTANCE IS SIMPLY THAT, AS HE ADMITTED, HE IS AFRAID THAT HIS SOLDIERS WILL TURN AGAINST HIM IF HE TAKES ACTION AGAINST THE WATSA COMPANY AND THAT HE THEREFORE WANTS THE CENTRAL GOVT TO TAKE THE RESPONSIBILITY, MAKING IT POSSIBLE FOR HIM TO "WASH HIS HANDS" IF TROUBLES SHOULD ARISE. EYE TOLD HIM THAT HE IS THE GENERAL AND AS SUCH RESPONSIBLE FOR HIS SOLDIERS BUT HIS FEAR OF HIS SOLDIERS IS APPARENTLY TOO STRONG. LUNDULLA FURTHER OBJECTED THAT THE DISARMING OF THE WATSA COMPANY IS A DIFFICULT AFFAIR AS IT IS IN THE BUSH WAITING FOR AN OPPORTUNITY TO ATTACK THE KATANGESE. THE BEST SOLUTION SEEMS TO BE THAT ADOULA CALLS LUNDULLA TO LEO IMMEDIATELY AFTER HIS RETURN AND TAKES A FIRM ATTITUDE TO HIM WITH CLEAR ORDERS FOR THE ROUND UP OF THE CULPRITS. IF SEEMS THAT LUNDULLA IS AWARE THAT THERE IS A WIDESPREAD SUPPORT
